OVERVIEW OF THE 12 PANEL NAIL BED DRUG TEST

THIS PROLONGED DETECTION CAPABILITY MAKES IT HIGHLY VALUABLE FOR MONITORING LONG-TERM DRUG USE OR ABSTINENCE. HOW THE 12 PANEL NAIL BED DRUG TEST WORKS

THE PROCESS OF THE 12 PANEL NAIL BED DRUG TEST INVOLVES COLLECTING NAIL SAMPLES FROM AN INDIVIDUAL, TYPICALLY BY CLIPPING FINGERNAILS OR TOENAILS. SAMPLE COLLECTION AND PREPARATION

DURING SAMPLE COLLECTION, CARE IS TAKEN TO AVOID CONTAMINATION. THE NAIL CLIPPINGS ARE CLEANED AND PREPARED FOR EXTRACTION OF THE DRUG COMPOUNDS. THIS PREPARATION INCLUDES WASHING, GRINDING, AND CHEMICALLY TREATING THE NAIL MATERIAL TO RELEASE METABOLITES. THE EXTRACTED SUBSTANCES ARE THEN ANALYZED USING SOPHISTICATED TECHNIQUES SUCH AS GAS CHROMATOGRAPHY-MASS SPECTROMETRY (GC-MS) OR LIQUID CHROMATOGRAPHY-TANDEM MASS SPECTROMETRY (LC-MS/MS) TO ENSURE ACCURATE AND RELIABLE RESULTS.

DETECTION WINDOW
