

# 17 PANEL HAIR FOLLICLE DRUG TEST

## WHAT IS A 17 PANEL HAIR FOLLICLE DRUG TEST?

## SAMPLE COLLECTION AND ANALYSIS

DURING THE COLLECTION PROCESS, A TECHNICIAN CUTS A SMALL AMOUNT OF HAIR CLOSE TO THE SCALP. IN CASES WHERE SCALP HAIR IS UNAVAILABLE, BODY HAIR MAY BE USED, ALTHOUGH THIS CAN AFFECT THE ACCURACY OF THE DETECTION WINDOW. THE COLLECTED HAIR IS THEN SENT TO A LABORATORY WHERE IT UNDERGOES WASHING TO REMOVE EXTERNAL CONTAMINANTS, FOLLOWED BY CHEMICAL ANALYSIS USING METHODS LIKE IMMUNOASSAY SCREENING AND GAS CHROMATOGRAPHY-MASS SPECTROMETRY (GC-MS) CONFIRMATION.

## DETECTION WINDOW
