OVERVIEW OF BEHAVIORAL HEALTH CPT CODES

CATEGORIES OF BEHAVIORAL HEALTH CPT CODES

THE BEHAVIORAL HEALTH CPT CODES CAN BE BROADLY CATEGORIZED INTO:

- DIAGNOSTIC EVALUATION CODES
- PSYCHOTHERAPY CODES

- INTERACTIVE COMPLEXITY CODES
- GROUP THERAPY CODES
- TELEHEALTH AND INTEGRATED CARE CODES

DIAGNOSTIC EVALUATION CPT CODES

DIAGNOSTIC EVALUATIONS ARE CRITICAL COMPONENTS OF BEHAVIORAL HEALTH CARE, INVOLVING COMPREHENSIVE ASSESSMENTS TO DETERMINE A PATIENT'S MENTAL HEALTH STATUS. THE CPT CODES FOR THESE SERVICES HELP DOCUMENT THE EXTENT OF EVALUATION PERFORMED AND SERVE AS A BASIS FOR TREATMENT PLANNING AND ONGOING CARE.

COMMON DIAGNOSTIC EVALUATION CODES

THE PRIMARY CODES USED FOR BEHAVIORAL HEALTH DIAGNOSTIC EVALUATIONS INCLUDE:

- **90791** – PSYCHIATRIC DIAGNOSTIC EVALUATION WITHOUT MEDICAL SERVICES
- **90792** – PSYCHIATRIC DIAGNOSTIC EVALUATION WITH MEDICAL SERVICES

CODE 90791 IS USED WHEN THE EVALUATION DOES NOT REQUIRE MEDICAL SERVICES SUCH AS PRESCRIBING MEDICATIONS, WHEREAS 90792 INCLUDES EVALUATION WITH MEDICAL MANAGEMENT.

WHEN TO USE DIAGNOSTIC EVALUATION CODES

THESE CODES ARE TYPICALLY USED DURING THE INITIAL VISIT OR WHEN A SIGNIFICANT DIAGNOSTIC REASSESSMENT IS NEEDED. PROPER DOCUMENTATION OF THE PATIENT'S HISTORY, MENTAL STATUS EXAM, AND DIAGNOSTIC IMPRESSIONS IS REQUIRED TO SUPPORT THE USE OF THESE CODES.

PSYCHOTHERAPY CPT CODES

PSYCHOTHERAPY SERVICES REPRESENT A SIGNIFICANT PORTION OF BEHAVIORAL HEALTH CARE, ENCOMPASSING A VARIETY OF THERAPEUTIC TECHNIQUES AIMED AT TREATING MENTAL HEALTH DISORDERS. THE CPT CODES FOR PSYCHOTHERAPY VARY BASED ON SESSION LENGTH AND WHETHER MEDICAL EVALUATION AND MANAGEMENT SERVICES ARE INCLUDED.

INDIVIDUAL PSYCHOTHERAPY CODES

THE COMMON PSYCHOTHERAPY CODES INCLUDE:

- **90832** – PSYCHOTHERAPY, 30 MINUTES WITH PATIENT
- **90834** – PSYCHOTHERAPY, 45 MINUTES WITH PATIENT
- **90837** – PSYCHOTHERAPY, 60 MINUTES WITH PATIENT

THESE CODES ARE USED TO BILL FOR TIME-BASED INDIVIDUAL THERAPY SESSIONS, WITH DOCUMENTATION REFLECTING THE DURATION AND NATURE OF THE SERVICE.

PSYCHOTHERAPY WITH EVALUATION AND MANAGEMENT

WHEN PSYCHOTHERAPY IS PROVIDED ALONGSIDE MEDICAL EVALUATION AND MANAGEMENT, THE FOLLOWING CODES APPLY:

- **90833** – PSYCHOTHERAPY, 30 MINUTES WITH PATIENT, WITH EVALUATION AND MANAGEMENT
- **90836** – PSYCHOTHERAPY, 45 MINUTES WITH PATIENT, WITH EVALUATION AND MANAGEMENT
- **90838** – PSYCHOTHERAPY, 60 MINUTES WITH PATIENT, WITH EVALUATION AND MANAGEMENT

INTERACTIVE AND GROUP THERAPY CODES

BEHAVIORAL HEALTH SERVICES OFTEN INCORPORATE INTERACTIVE COMPLEXITY AND GROUP THERAPY SESSIONS, WHICH HAVE DISTINCT CPT CODES FOR ACCURATE BILLING AND REPORTING.

INTERACTIVE COMPLEXITY CODE

THE INTERACTIVE COMPLEXITY ADD-ON CODE IS:

- **90785** – INTERACTIVE COMPLEXITY, USED AS AN ADD-ON CODE TO PSYCHOTHERAPY SERVICES

THIS CODE IS APPLIED WHEN FACTORS SUCH AS COMMUNICATION DIFFICULTIES, INVOLVEMENT OF THIRD PARTIES, OR USE OF PLAY EQUIPMENT IN THERAPY INCREASE THE COMPLEXITY OF THE SESSION.

GROUP THERAPY CODES

GROUP THERAPY INVOLVES TREATING MULTIPLE PATIENTS SIMULTANEOUSLY AND HAS SEPARATE CODES:

- **90849** – MULTIPLE-FAMILY GROUP PSYCHOTHERAPY
- **90853** – GROUP PSYCHOTHERAPY (OTHER THAN MULTIPLE-FAMILY GROUP)

THESE CODES REQUIRE DOCUMENTATION OF THE GROUP SETTING AND THE THERAPEUTIC INTERVENTIONS PROVIDED.

TELEHEALTH AND INTEGRATED CARE CPT CODES

THE RISE OF TELEHEALTH AND INTEGRATED BEHAVIORAL HEALTH CARE HAS LED TO EXPANDED CPT CODES THAT ACCOMMODATE REMOTE SERVICES AND COLLABORATIVE CARE MODELS.

TELEHEALTH BEHAVIORAL HEALTH CODES

TELEHEALTH SERVICES USE THE SAME CPT CODES AS IN-PERSON VISITS BUT REQUIRE APPROPRIATE MODIFIERS AND PLACE OF SERVICE CODES TO INDICATE VIRTUAL DELIVERY. PROVIDERS MUST FOLLOW PAYER-SPECIFIC GUIDELINES TO ENSURE REIMBURSEMENT.

INTEGRATED BEHAVIORAL HEALTH CODES

INTEGRATED CARE CODES SUPPORT BILLING FOR BEHAVIORAL HEALTH SERVICES PROVIDED IN PRIMARY CARE OR OTHER MEDICAL SETTINGS, INCLUDING:

- **99492** – INITIAL PSYCHIATRIC COLLABORATIVE CARE MANAGEMENT
- **99493** – SUBSEQUENT PSYCHIATRIC COLLABORATIVE CARE MANAGEMENT
- **99494** – INITIAL OR SUBSEQUENT PSYCHIATRIC COLLABORATIVE CARE MANAGEMENT TEAM COMMUNICATION

THESE CODES FACILITATE REIMBURSEMENT FOR COLLABORATIVE EFFORTS BETWEEN BEHAVIORAL HEALTH SPECIALISTS AND MEDICAL PROVIDERS.

UPDATES AND CHANGES FOR 2024

COMMON CODING PITFALLS TO AVOID

COMMON ERRORS INCLUDE:

- USING OUTDATED CODES OR NEGLECTING ANNUAL UPDATES
- INCORRECTLY BUNDLING SERVICES OR DUPLICATING CODES
- INADEQUATE DOCUMENTATION SUPPORTING THE BILLED SERVICE
- FAILURE TO APPLY TELEHEALTH MODIFIERS WHEN REQUIRED

TIPS FOR OPTIMIZING CLAIMS SUBMISSION

TO OPTIMIZE CLAIMS PROCESSING, PROVIDERS SHOULD:

- VERIFY PAYER-SPECIFIC CODING GUIDELINES BEFORE SUBMISSION
- USE ELECTRONIC HEALTH RECORDS TO STREAMLINE DOCUMENTATION
- TRAIN STAFF REGULARLY ON CODING UPDATES AND COMPLIANCE
- CONDUCT INTERNAL AUDITS TO IDENTIFY AND CORRECT ERRORS PROMPTLY

Previously an E/M (evaluation and management) note required documentation of history, exam, and medical decision-making with required elements in each component to support a level for payment. If an element was missing, the level of service was not supported; therefore, the code was lowered, resulting in a lower reimbursement for the physician/provider. The new guidelines eliminated the requirement of History and Exam as part of the calculation of a code level. Yes, an appropriate history and exam are required, this supports good patient care, but when it comes to reimbursement, they are no longer part of the picture. The overall system is not difficult, if time is taken to understand the elements and how they are applied in the documentation. Documentation is a "word game" always has been, the authors' focus is to show what words to use to lessen the time but still convey the complexity of the patient's condition, and how the physician/provider determines a treatment plan which includes the risk to the patient to satisfy the Coding guidelines initiated by Medicare and American Medical Association. This book evaluates the new guidelines and brings them into prospective so physicians/providers/coders can

easily understand how to document and calculate the level of service for reimbursement. This is not a cumbersome book or complicated, but straight to the point. The main goal of the book is to educate physicians, nurses, and coders on what documentation is really required and what has just become habit over the last 30 years.
