OVERVIEW OF BELLEVUE UNIVERSITY FINANCIAL AID

BELLEVUE UNIVERSITY FINANCIAL AID IS DESIGNED TO PROVIDE FINANCIAL SUPPORT TO STUDENTS WHO DEMONSTRATE NEED OR MERIT, HELPING TO REDUCE THE COST BURDEN OF HIGHER EDUCATION. THE UNIVERSITY PARTICIPATES IN FEDERAL AND STATE FINANCIAL AID PROGRAMS, AS WELL AS OFFERING ITS OWN INSTITUTIONAL AID PACKAGES. THE FINANCIAL AID OFFICE WORKS CLOSELY WITH STUDENTS TO ENSURE THEY UNDERSTAND THEIR OPTIONS AND MEET ALL NECESSARY REQUIREMENTS. WHETHER ATTENDING FULL-TIME OR PART-TIME, ONLINE OR ON-CAMPUS, STUDENTS AT BELLEVUE UNIVERSITY HAVE ACCESS TO A VARIETY OF FINANCIAL RESOURCES TAILORED TO THEIR ACADEMIC GOALS AND FINANCIAL SITUATIONS.

TYPES OF FINANCIAL AID AVAILABLE

THE FINANCIAL AID OFFERINGS AT BELLEVUE UNIVERSITY ENCOMPASS SEVERAL CATEGORIES TO ACCOMMODATE DIVERSE STUDENT NEEDS. THESE INCLUDE FEDERAL AND STATE GRANTS, SCHOLARSHIPS, STUDENT LOANS, AND WORK-STUDY PROGRAMS. EACH TYPE SERVES A UNIQUE PURPOSE AND HAS SPECIFIC QUALIFICATION CRITERIA. GRANTS

GRANTS ARE A FORM OF FINANCIAL AID THAT GENERALLY DO NOT REQUIRE REPAYMENT. BELLEVUE UNIVERSITY STUDENTS MAY QUALIFY FOR FEDERAL GRANTS SUCH AS THE PELL GRANT, AS WELL AS STATE-FUNDED GRANTS DEPENDING ON RESIDENCY STATUS. THESE FUNDS ARE TYPICALLY AWARDED BASED ON FINANCIAL NEED AND ARE AN ESSENTIAL COMPONENT OF MANY STUDENTS' AID PACKAGES.

SCHOLARSHIPS

SCHOLARSHIPS ARE MERIT-BASED OR NEED-BASED AWARDS THAT DO NOT HAVE TO BE REPAYED. BELLEVUE UNIVERSITY OFFERS A VARIETY OF SCHOLARSHIPS TO RECOGNIZE ACADEMIC ACHIEVEMENT, LEADERSHIP, COMMUNITY SERVICE, AND OTHER CRITERIA. INSTITUTIONAL SCHOLARSHIPS MAY BE RENEWABLE AND VARY IN AMOUNT, PROVIDING SIGNIFICANT FINANCIAL RELIEF TO RECIPIENTS.

LOANS

STUDENT LOANS AT BELLEVUE UNIVERSITY INCLUDE FEDERAL DIRECT LOANS AND PRIVATE LOAN OPTIONS. WHILE LOANS MUST BE REPAYED WITH INTEREST, THEY OFTEN OFFER FAVORABLE TERMS SUCH AS FIXED INTEREST RATES AND INCOME-DRIVEN REPAYMENT PLANS. UNDERSTANDING LOAN OPTIONS AND RESPONSIBLY BORROWING IS CRITICAL FOR MANAGING POST-GRADUATION FINANCIAL OBLIGATIONS.

Work-STUDY

THE FEDERAL WORK-STUDY PROGRAM OFFERS PART-TIME EMPLOYMENT OPPORTUNITIES TO ELIGIBLE STUDENTS, ALLOWING THEM TO EARN MONEY TO HELP PAY FOR EDUCATIONAL EXPENSES. BELLEVUE UNIVERSITY PROVIDES WORK-STUDY POSITIONS ON CAMPUS OR WITH APPROVED OFF-CAMPUS EMPLOYERS, ENABLING STUDENTS TO GAIN WORK EXPERIENCE WHILE FUNDING THEIR EDUCATION.

ELIGIBILITY AND APPLICATION PROCESS

APPLYING FOR BELLEVUE UNIVERSITY FINANCIAL AID REQUIRES MEETING SPECIFIC ELIGIBILITY CRITERIA AND COMPLETING THE NECESSARY APPLICATION FORMS ACCURATELY AND ON TIME. THE FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA) IS THE PRIMARY APPLICATION USED TO DETERMINE ELIGIBILITY FOR FEDERAL AND INSTITUTIONAL AID. BELLEVUE UNIVERSITY ENCOURAGES STUDENTS TO SUBMIT THEIR FAFSA EARLY TO MAXIMIZE THEIR FINANCIAL AID OPPORTUNITIES.

FAFSA SUBMISSION

COMPLETING THE FAFSA IS THE FIRST STEP IN ACCESSING MOST FEDERAL AND STATE FINANCIAL AID PROGRAMS. STUDENTS MUST PROVIDE DETAILED FINANCIAL INFORMATION, WHICH IS USED TO CALCULATE THE EXPECTED FAMILY CONTRIBUTION (EFC). THE EFC HELPS DETERMINE THE AMOUNT AND TYPES OF AID AWARDED TO EACH STUDENT.

ADDITIONAL DOCUMENTATION

IN SOME CASES, BELLEVUE UNIVERSITY MAY REQUIRE STUDENTS TO SUBMIT ADDITIONAL DOCUMENTATION SUCH AS TAX TRANSCRIPTS, VERIFICATION FORMS, OR PROOF OF ENROLLMENT STATUS. PROMPTLY RESPONDING TO REQUESTS FROM THE FINANCIAL AID OFFICE HELPS PREVENT DELAYS IN AID DISBURSEMENT.

ENROLLMENT STATUS AND SATISFACTORY ACADEMIC PROGRESS

TO MAINTAIN ELIGIBILITY FOR FINANCIAL AID, STUDENTS MUST MEET ENROLLMENT REQUIREMENTS, TYPICALLY AT LEAST HALF-TIME STATUS, AND ADHERE TO THE UNIVERSITY'S SATISFACTORY ACADEMIC PROGRESS POLICIES. THESE POLICIES ENSURE STUDENTS SUCCESSFULLY COMPLETE COURSES AND PROGRESS TOWARD THEIR DEGREES.

SCHOLARSHIPS AND GRANTS

BELLEVUE UNIVERSITY OFFERS A WIDE RANGE OF SCHOLARSHIPS AND GRANTS THAT REDUCE THE OVERALL COST OF ATTENDANCE. THESE AWARDS RECOGNIZE BOTH ACADEMIC EXCELLENCE AND FINANCIAL NEED, ENABLING STUDENTS TO FOCUS MORE FULLY ON THEIR STUDIES WITHOUT UNDUE FINANCIAL STRESS.

MERIT-BASED SCHOLARSHIPS

MERIT SCHOLARSHIPS REWARD STUDENTS FOR OUTSTANDING ACADEMIC PERFORMANCE, LEADERSHIP ABILITIES, OR SPECIAL TALENTS. THESE SCHOLARSHIPS MAY BE BASED ON HIGH SCHOOL GPA, STANDARDIZED TEST SCORES, OR OTHER CRITERIA SET BY THE UNIVERSITY.

NEED-BASED GRANTS

NEED-BASED GRANTS ARE AWARDED TO STUDENTS WHO DEMONSTRATE FINANCIAL NEED THROUGH THE FAFSA PROCESS. THESE GRANTS HELP BRIDGE THE GAP BETWEEN FAMILY CONTRIBUTIONS AND THE TOTAL COST OF ATTENDANCE, MAKING EDUCATION MORE AFFORDABLE FOR LOW- AND MODERATE-INCOME STUDENTS.

EXTERNAL SCHOLARSHIP OPPORTUNITIES

IN ADDITION TO INSTITUTIONAL AWARDS, BELLEVUE UNIVERSITY ENCOURAGES STUDENTS TO SEEK EXTERNAL SCHOLARSHIPS OFFERED BY COMMUNITY ORGANIZATIONS, FOUNDATIONS, AND EMPLOYERS. THESE EXTERNAL FUNDS CAN SUPPLEMENT UNIVERSITY AID AND FURTHER REDUCE OUT-OF-POCKET EXPENSES.

LOANS AND REPAYMENT OPTIONS

WHEN SCHOLARSHIPS AND GRANTS DO NOT FULLY COVER COSTS, LOANS BECOME AN IMPORTANT OPTION FOR FINANCING EDUCATION AT BELLEVUE UNIVERSITY. UNDERSTANDING LOAN TYPES, BORROWING LIMITS, AND REPAYMENT PLANS IS ESSENTIAL FOR MANAGING STUDENT DEBT RESPONSIBLY.

FEDERAL STUDENT LOANS

BELLEVUE UNIVERSITY PARTICIPATES IN FEDERAL STUDENT LOAN PROGRAMS SUCH AS THE DIRECT SUBSIDIZED AND UNSUBSIDIZED LOANS. SUBSIDIZED LOANS DO NOT ACCRUE INTEREST WHILE THE STUDENT IS ENROLLED, WHEREAS UNSUBSIDIZED LOANS BEGIN ACCRUING INTEREST IMMEDIATELY. LOAN ELIGIBILITY IS DETERMINED BASED ON FAFSA RESULTS AND ENROLLMENT STATUS.

PRIVATE LOANS

PRIVATE LOANS FROM BANKS OR LENDING INSTITUTIONS MAY BE USED TO COVER REMAINING COSTS NOT MET BY FEDERAL AID. THESE LOANS OFTEN REQUIRE CREDIT CHECKS AND MAY HAVE HIGHER INTEREST RATES, SO THEY SHOULD BE CONSIDERED CAREFULLY. BELLEVUE UNIVERSITY PROVIDES COUNSELING TO HELP STUDENTS EVALUATE THESE OPTIONS.

REPAYMENT PLANS

FEDERAL LOANS OFFER FLEXIBLE REPAYMENT PLANS INCLUDING STANDARD, GRADUATED, AND INCOME-DRIVEN OPTIONS THAT ADJUST MONTHLY PAYMENTS BASED ON INCOME AND FAMILY SIZE. BELLEVUE UNIVERSITY'S FINANCIAL AID ADVISORS ASSIST BORROWERS IN SELECTING THE BEST REPAYMENT STRATEGY TO MANAGE THEIR DEBT EFFICIENTLY AFTER GRADUATION.

WORK-STUDY AND EMPLOYMENT OPPORTUNITIES

OFF-CAMPUS EMPLOYMENT

SOME WORK-STUDY POSITIONS ARE AVAILABLE WITH APPROVED NON-PROFIT ORGANIZATIONS AND PUBLIC AGENCIES. THESE OPPORTUNITIES CAN PROVIDE PRACTICAL EXPERIENCE RELEVANT TO STUDENTS' CAREER GOALS WHILE EARNING WAGES.

APPLICATION AND ELIGIBILITY

TO QUALIFY FOR WORK-STUDY, STUDENTS MUST INDICATE INTEREST ON THEIR FAFSA AND MEET ELIGIBILITY CRITERIA. BELLEVUE UNIVERSITY'S FINANCIAL AID OFFICE ASSISTS WITH JOB PLACEMENT AND PROVIDES GUIDANCE ON BALANCING WORK AND ACADEMIC RESPONSIBILITIES.

IMPORTANT DEADLINES AND TIPS FOR SUCCESS

MEETING APPLICATION DEADLINES AND SUBMITTING COMPLETE DOCUMENTATION ARE VITAL STEPS IN SECURING BELLEVUE UNIVERSITY FINANCIAL AID. EARLY PLANNING AND PROACTIVE COMMUNICATION WITH THE FINANCIAL AID OFFICE CAN IMPROVE THE CHANCES OF RECEIVING MAXIMUM AID.

TIPS FOR MAXIMIZING FINANCIAL AID

1. COMPLETE THE FAFSA AS SOON AS POSSIBLE AFTER OCTOBER 1 EACH YEAR.
2. MAINTAIN SATISFACTORY ACADEMIC PROGRESS TO REMAIN ELIGIBLE FOR AID.
3. EXPLORE ALL SCHOLARSHIP OPPORTUNITIES OFFERED BY BELLEVUE UNIVERSITY AND EXTERNAL SOURCES.
4. COMMUNICATE PROMPTLY WITH THE FINANCIAL AID OFFICE REGARDING ANY CHANGES IN FINANCIAL OR ENROLLMENT STATUS.
5. CONSIDER WORK-STUDY POSITIONS TO SUPPLEMENT FINANCIAL AID PACKAGES.
6. BORROW STUDENT LOANS RESPONSIBLY AND UNDERSTAND REPAYMENT OBLIGATIONS.

RESOURCES AND SUPPORT
