THE ORGANIZATION AIMS TO BRIDGE THE GAP BETWEEN INNOVATIVE IDEAS AND MARKET-READY PRODUCTS BY OFFERING STARTUPS THE TOOLS AND GUIDANCE NECESSARY TO SUCCEED. BFTP NEP FOCUSES ON A DIVERSE RANGE OF INDUSTRIES, INCLUDING INFORMATION TECHNOLOGY, ADVANCED MANUFACTURING, LIFE SCIENCES, AND CLEAN TECHNOLOGY. ORGANIZATIONAL STRUCTURE

BFTP NEP OPERATES AS A PUBLIC-PRIVATE PARTNERSHIP, LEVERAGING STATE FUNDS ALONGSIDE PRIVATE INVESTMENTS AND PARTNERSHIPS WITH UNIVERSITIES, RESEARCH INSTITUTIONS, AND INDUSTRY STAKEHOLDERS. THE ORGANIZATION IS GOVERNED BY A BOARD OF DIRECTORS COMPRISING COMMUNITY LEADERS, BUSINESS EXECUTIVES, AND TECHNOLOGY EXPERTS WHO PROVIDE STRATEGIC OVERSIGHT AND DIRECTION.

FUNDING AND INVESTMENT PROGRAMS
