OVERVIEW OF BERKSHIRE HATHAWAY'S MANAGEMENT STRUCTURE

THE BERKSHIRE HATHAWAY MANAGEMENT TEAM IS STRUCTURED TO ACCOMMODATE THE VAST AND VARIED NATURE OF ITS HOLDINGS, WHICH SPAN MULTIPLE INDUSTRIES INCLUDING INSURANCE, UTILITIES, MANUFACTURING, RETAIL, AND MORE. THE COMPANY OPERATES AS A DECENTRALIZED CONGLOMERATE, WHERE NUMEROUS SUBSIDIARIES MAINTAIN OPERATIONAL INDEPENDENCE WHILE BENEFITING FROM OVERARCHING STRATEGIC OVERSIGHT PROVIDED BY THE CENTRAL MANAGEMENT TEAM. THIS STRUCTURE ALLOWS FLEXIBILITY AND AUTONOMY FOR SUBSIDIARY MANAGERS TO MAKE DECISIONS THAT BEST SUIT THEIR MARKETS WHILE ALIGNING WITH THE PARENT COMPANY'S LONG-TERM GOALS.

AT THE TOP OF THIS STRUCTURE SITS THE BOARD OF DIRECTORS AND EXECUTIVE LEADERSHIP, INCLUDING THE CEO AND VICE CHAIRMAN. BENEATH THEM, A NETWORK OF PRESIDENTS, CEOs, AND MANAGEMENT TEAMS OF INDIVIDUAL BERKSHIRE HATHAWAY SUBSIDIARIES EXECUTE DAILY OPERATIONS. THIS LAYERED MANAGEMENT DESIGN IS A HALLMARK OF BERKSHIRE HATHAWAY'S APPROACH, BALANCING CENTRALIZED CAPITAL ALLOCATION WITH DECENTRALIZED OPERATIONAL CONTROL.

DECENTRALIZATION AS A CORE PRINCIPLE

DECENTRALIZATION ENABLES THE BERKSHIRE HATHAWAY MANAGEMENT TEAM TO MAXIMIZE EFFICIENCY BY EMPOWERING SUBSIDIARY MANAGERS. THIS APPROACH REDUCES BUREAUCRACY AND FOSTERS ENTREPRENEURIAL SPIRIT WITHIN THE COMPANY'S MANY BUSINESSES. THE CENTRAL TEAM FOCUSES ON CAPITAL DEPLOYMENT, ACQUISITION DECISIONS, AND MAJOR STRATEGIC INITIATIVES, WHILE SUBSIDIARY LEADERS HANDLE OPERATIONAL MATTERS.

ROLE OF THE BOARD OF DIRECTORS

THE BOARD OF DIRECTORS PROVIDES GOVERNANCE AND OVERSIGHT, ENSURING THAT THE BERKSHIRE HATHAWAY MANAGEMENT TEAM ADHERES TO PRINCIPLES OF SOUND MANAGEMENT AND LONG-TERM VALUE CREATION. THE BOARD INCLUDES SEASONED BUSINESS LEADERS WHO CONTRIBUTE TO MAJOR DECISION-MAKING AND SUCCESSION PLANNING.

CHARLIE MUNGER – VICE CHAIRMAN

CHARLIE MUNGER SERVES AS THE VICE CHAIRMAN AND IS WIDELY RECOGNIZED FOR HIS SHARP INTELLECT AND COMPLEMENTARY INVESTMENT INSIGHTS. MUNGER PLAYS A CRITICAL ADVISORY ROLE, CONTRIBUTING TO STRATEGIC DISCUSSIONS AND HELPING GUIDE THE COMPANY'S INVESTMENT PHILOSOPHY ALONGSIDE BUFFETT.

GREG ABEL – VICE CHAIRMAN OF NON-INSURANCE OPERATIONS

GREG ABEL OVERSEES THE NON-INSURANCE BUSINESSES OF BERKSHIRE HATHAWAY AND IS CONSIDERED A KEY FIGURE IN THE COMPANY'S SUCCESSION PLANNING. HIS LEADERSHIP SPANS NUMEROUS SUBSIDIARIES AND OPERATIONAL AREAS, ENSURING THAT THE DIVERSE BUSINESSES UNDER THE BERKSHIRE UMBRELLA PERFORM EFFECTIVELY.

AJIT JAIN – VICE CHAIRMAN OF INSURANCE OPERATIONS

AJIT JAIN LEADS BERKSHIRE HATHAWAY'S INSURANCE OPERATIONS, A CORE SEGMENT OF THE COMPANY'S PORTFOLIO. JAIN IS CREDITED WITH EXPANDING BERKSHIRE'S INSURANCE FOOTPRINT AND ENHANCING UNDERWRITING DISCIPLINE, CONTRIBUTING SIGNIFICANTLY TO THE COMPANY'S PROFITABILITY AND RISK MANAGEMENT.

LEADERSHIP PHILOSOPHY AND CORPORATE CULTURE

THE BERKSHIRE HATHAWAY MANAGEMENT TEAM IS UNITED BY A LEADERSHIP PHILOSOPHY GROUNDED IN INTEGRITY, LONG-TERM VALUE CREATION, AND TRUST. THIS CULTURE EMPHASIZES PRUDENT RISK-TAKING, DECENTRALIZED DECISION-MAKING, AND A FOCUS ON INTRINSIC BUSINESS VALUE RATHER THAN SHORT-TERM MARKET FLUCTUATIONS. THE MANAGEMENT TEAM FOSTERS AN ENVIRONMENT WHERE TRANSPARENCY AND ETHICAL BUSINESS PRACTICES ARE PARAMOUNT.

LONG-TERM INVESTMENT HORIZON

ONE OF THE DEFINING ELEMENTS OF THE BERKSHIRE HATHAWAY MANAGEMENT TEAM'S PHILOSOPHY IS ITS COMMITMENT TO LONG-TERM INVESTMENTS. RATHER THAN CHASING QUICK PROFITS, THE TEAM PRIORITIZES SUSTAINABLE GROWTH AND DURABLE COMPETITIVE ADVANTAGES IN PORTFOLIO COMPANIES.

EMPOWERMENT AND ACCOUNTABILITY

BERKSHIRE HATHAWAY'S CULTURE ENCOURAGES SUBSIDIARY MANAGERS TO OPERATE WITH SIGNIFICANT AUTONOMY, PROVIDED THEY MAINTAIN ACCOUNTABILITY FOR RESULTS. THIS EMPOWERMENT HAS BEEN KEY TO ATTRACTING AND RETAINING HIGHLY CAPABLE LEADERS WHO ALIGN WITH THE COMPANY'S VALUES.

FRUGALITY AND EFFICIENCY

THE MANAGEMENT TEAM ADVOCATES FOR OPERATIONAL EFFICIENCY AND COST-CONSCIOUSNESS ACROSS ALL BUSINESSES. THIS FRUGALITY, COUPLED WITH DISCIPLINED CAPITAL ALLOCATION, ENSURES THAT RESOURCES ARE USED EFFECTIVELY TO GENERATE SHAREHOLDER VALUE.

STRATEGIC MANAGEMENT AND DECISION-MAKING PROCESSES

THE BERKSHIRE HATHAWAY MANAGEMENT TEAM APPROACHES STRATEGIC MANAGEMENT WITH A BLEND OF RIGOROUS ANALYSIS AND INTUITIVE JUDGMENT. CAPITAL ALLOCATION DECISIONS, ACQUISITIONS, AND INVESTMENT CHOICES UNDERGO CAREFUL EVALUATION TO MAINTAIN THE COMPANY'S FINANCIAL STRENGTH AND COMPETITIVE EDGE.

CAPITAL ALLOCATION

EFFECTIVE CAPITAL ALLOCATION IS A CORNERSTONE OF THE BERKSHIRE HATHAWAY MANAGEMENT TEAM'S STRATEGY. BUFFETT AND HIS TEAM ASSESS OPPORTUNITIES WITH A FOCUS ON RETURNS RELATIVE TO RISK, OFTEN PREFERRING TO REINVEST IN EXISTING BUSINESSES OR ACQUIRE NEW COMPANIES WITH STRONG FUNDAMENTALS AND MANAGEMENT TEAMS.

ACQUISITION STRATEGY

ACQUISITIONS ARE A PIVOTAL PART OF BERKSHIRE HATHAWAY'S GROWTH STRATEGY. THE MANAGEMENT TEAM LOOKS FOR COMPANIES WITH DURABLE MOATS, STRONG CASH FLOWS, AND CAPABLE LEADERSHIP. DUE DILIGENCE IS THOROUGH, BUT THE TEAM IS KNOWN FOR ACTING DECISIVELY WHEN OPPORTUNITIES ALIGN WITH THEIR CRITERIA.

RISK MANAGEMENT

GIVEN THE DIVERSE NATURE OF BERKSHIRE HATHAWAY'S HOLDINGS, RISK MANAGEMENT IS A CRITICAL FUNCTION OF THE MANAGEMENT TEAM. THROUGH DIVERSIFICATION, CONSERVATIVE UNDERWRITING IN INSURANCE, AND CAREFUL FINANCIAL OVERSIGHT, THE TEAM MITIGATES RISKS TO PROTECT SHAREHOLDER CAPITAL.

IMPACT OF THE MANAGEMENT TEAM ON BERKSHIRE HATHAWAY'S SUCCESS

THE BERKSHIRE HATHAWAY MANAGEMENT TEAM'S COLLECTIVE EXPERTISE AND DISCIPLINED APPROACH HAVE BEEN FUNDAMENTAL TO THE COMPANY'S UNRIVALED SUCCESS OVER THE DECADES. BERKSHIRE HATHAWAY OPERATES WITH A DECENTRALIZED MANAGEMENT STRUCTURE WHERE SUBSIDIARY COMPANIES ARE RUN INDEPENDENTLY BY THEIR OWN MANAGEMENT TEAMS, WHILE THE PARENT COMPANY PROVIDES CAPITAL ALLOCATION AND STRATEGIC GUIDANCE THROUGH ITS EXECUTIVE LEADERSHIP.

CHARLIE MUNGER IS THE VICE CHAIRMAN OF BERKSHIRE HATHAWAY AND WARREN BUFFETT'S LONGTIME BUSINESS PARTNER. HE CONTRIBUTES TO MAJOR INVESTMENT DECISIONS AND PROVIDES STRATEGIC ADVICE TO THE COMPANY'S MANAGEMENT TEAM.
