# CALIFORNIA BOARD OF BEHAVIORAL SCIENCES (BBS) LICENSING

THE CALIFORNIA BBS REGULATES MFT LICENSURE AND MANDATES SPECIFIC EDUCATIONAL AND CLINICAL EXPERIENCE CRITERIA. TO BECOME A LICENSED MARRIAGE AND FAMILY THERAPIST IN CALIFORNIA, CANDIDATES MUST:

1. GRADUATE FROM A BBS-APPROVED OR COAMFTE-ACCREDITED PROGRAM.
2. COMPLETE AT LEAST 3,000 HOURS OF SUPERVISED CLINICAL EXPERIENCE.
3. PASS THE CALIFORNIA LAW AND ETHICS EXAM.
4. PASS THE NATIONAL MFT LICENSING EXAM.

PROGRAMS THAT ALIGN THEIR CURRICULUM AND PRACTICUM REQUIREMENTS WITH BBS STANDARDS PROVIDE STUDENTS WITH A CLEAR PATHWAY TO LICENSURE.

## CURRICULUM AND CLINICAL TRAINING COMPONENTS

THE CURRICULUM OF THE BEST MARRIAGE AND FAMILY THERAPY PROGRAMS IN CALIFORNIA INCLUDES A BLEND OF THEORETICAL COURSEWORK, RESEARCH METHODS, AND EXTENSIVE CLINICAL TRAINING.
