FEASIBILITY AND RESOURCE AVAILABILITY

CONSIDERATION MUST BE GIVEN TO THE AVAILABILITY OF DATA, ACCESS TO PARTICIPANTS, TIME CONSTRAINTS, AND FUNDING. PRACTICAL FEASIBILITY ENSURES THE RESEARCH CAN BE COMPLETED EFFECTIVELY.

ETHICAL CONSIDERATIONS

GIVEN THE SENSITIVE NATURE OF CRIMINAL JUSTICE RESEARCH, TOPICS MUST COMPLY WITH ETHICAL STANDARDS, PROTECTING THE RIGHTS AND PRIVACY OF PARTICIPANTS, ESPECIALLY WHEN DEALING WITH VULNERABLE POPULATIONS.

SCOPE AND SPECIFICITY

OUTLINE ETHICAL PROTOCOLS

INCLUDE DETAILED PLANS FOR OBTAINING INFORMED CONSENT, ENSURING CONFIDENTIALITY, AND MINIMIZING HARM TO PARTICIPANTS.

PLAN FOR DATA COLLECTION AND ANALYSIS
