THIS POSITION HAS FOSTERED THE GROWTH OF ORGANIZED CRIMINAL NETWORKS INVOLVED IN DRUG TRAFFICKING, MONEY LAUNDERING, AND RELATED VIOLENT CRIMES. THESE NETWORKS COMPLICATE LAW ENFORCEMENT EFFORTS AND EXACERBATE INSTABILITY IN CERTAIN COUNTRIES.

WHITE-COLLAR AND CYBER CRIMES

IMPACT OF TOURISM ON CRIME DISTRIBUTION
