OVERVIEW OF THE CREST PRO HEALTH MOUTHWASH LAWSUIT

THE CREST PRO HEALTH MOUTHWASH LAWSUIT CENTERS ON ALLEGATIONS THAT THE PRODUCT MAY CAUSE HARM TO CONSUMERS DUE TO THE PRESENCE OF CERTAIN HARMFUL INGREDIENTS. PLAINTIFFS ARGUE THAT THE FORMULATION MIGHT EXCEED SAFE EXPOSURE LIMITS OR THAT THE COMBINATION OF INGREDIENTS LEADS TO UNEXPECTED HEALTH RISKS.

MARKETING AND LABELING ISSUES
