OVERVIEW OF THE CT DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT

THE CT DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT IS A STATE GOVERNMENT AGENCY RESPONSIBLE FOR PROMOTING ECONOMIC GROWTH AND COMMUNITY REVITALIZATION ACROSS CONNECTICUT. ITS PRIMARY MISSION IS TO SUPPORT BUSINESSES, FOSTER INNOVATION, AND IMPROVE THE ECONOMIC VITALITY OF THE STATE THROUGH STRATEGIC PLANNING, FINANCIAL ASSISTANCE, AND RESOURCE COORDINATION. ESTABLISHED TO STREAMLINE ECONOMIC DEVELOPMENT EFFORTS, THE DEPARTMENT SERVES AS A CENTRAL POINT FOR BUSINESS ATTRACTION, RETENTION, AND EXPANSION ACTIVITIES. IT ALSO WORKS CLOSELY WITH MUNICIPALITIES AND LOCAL ORGANIZATIONS TO ADDRESS COMMUNITY NEEDS AND ENCOURAGE SUSTAINABLE DEVELOPMENT. THE DECD'S VISION INCLUDES CREATING AN INCLUSIVE ECONOMY THAT BENEFITS ALL RESIDENTS BY SUPPORTING DIVERSE INDUSTRIES AND REGIONS WITHIN CONNECTICUT.

MISSION AND OBJECTIVES

THE MISSION OF THE CT DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT IS TO ENHANCE THE STATE'S ECONOMIC COMPETITIVENESS AND QUALITY OF LIFE BY:

- PROMOTING WORKFORCE DEVELOPMENT AND SKILLS TRAINING

- ENCOURAGING SUSTAINABLE AND EQUITABLE DEVELOPMENT PRACTICES

ORGANIZATIONAL STRUCTURE

THE DEPARTMENT IS STRUCTURED INTO SEVERAL DIVISIONS THAT FOCUS ON DISTINCT YET INTERCONNECTED AREAS SUCH AS BUSINESS DEVELOPMENT, COMMUNITY REVITALIZATION, INTERNATIONAL TRADE, AND TOURISM. EACH DIVISION IS STAFFED WITH SPECIALISTS WHO PROVIDE EXPERTISE AND RESOURCES TAILORED TO THE NEEDS OF BUSINESSES AND COMMUNITIES. LEADERSHIP AT THE DECD ENSURES ALIGNMENT WITH STATE ECONOMIC GOALS AND FACILITATES COORDINATION WITH OTHER GOVERNMENT AGENCIES AND PRIVATE SECTOR PARTNERS.

KEY PROGRAMS AND INITIATIVES

THE CT DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT OFFERS A WIDE ARRAY OF PROGRAMS DESIGNED TO SUPPORT ECONOMIC GROWTH AND COMMUNITY WELL-BEING. THESE INITIATIVES ADDRESS DIFFERENT ASPECTS OF DEVELOPMENT, INCLUDING FINANCIAL INCENTIVES, WORKFORCE TRAINING, AND INFRASTRUCTURE IMPROVEMENT. THE DEPARTMENT CONTINUOUSLY ADAPTS ITS PROGRAMS TO MEET EVOLVING MARKET DEMANDS AND TO MAXIMIZE IMPACT ACROSS CONNECTICUT'S DIVERSE REGIONS.

FINANCIAL INCENTIVE PROGRAMS

ONE OF THE DEPARTMENT'S CORE FUNCTIONS IS TO ADMINISTER FINANCIAL INCENTIVES THAT ENCOURAGE BUSINESS INVESTMENT AND JOB CREATION. THESE INCENTIVES INCLUDE GRANTS, LOANS, TAX CREDITS, AND OTHER FORMS OF ASSISTANCE AIMED AT REDUCING COSTS AND RISKS FOR BUSINESSES LOCATING OR EXPANDING IN CONNECTICUT.

WORKFORCE DEVELOPMENT INITIATIVES

RECOGNIZING THE IMPORTANCE OF A SKILLED WORKFORCE, THE DECD PARTNERS WITH EDUCATIONAL INSTITUTIONS AND TRAINING ORGANIZATIONS TO PROVIDE PROGRAMS THAT ENHANCE EMPLOYEE SKILLS AND PREPARE WORKERS FOR EMERGING INDUSTRIES. THESE INITIATIVES HELP BUSINESSES FIND QUALIFIED TALENT AND SUPPORT CAREER ADVANCEMENT OPPORTUNITIES FOR CONNECTICUT RESIDENTS.

COMMUNITY REVITALIZATION EFFORTS

THE DEPARTMENT ALSO FOCUSES ON REVITALIZING URBAN AND RURAL COMMUNITIES THROUGH TARGETED INVESTMENTS IN INFRASTRUCTURE, HOUSING, AND PUBLIC SPACES. THESE EFFORTS AIM TO IMPROVE LIVING CONDITIONS, ATTRACT RESIDENTS AND BUSINESSES, AND FOSTER ECONOMIC RESILIENCE AT THE LOCAL LEVEL.

BUSINESS SUPPORT AND INCENTIVES

THE CT DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT PROVIDES A COMPREHENSIVE SUITE OF SUPPORTS AND INCENTIVES TAILORED TO THE NEEDS OF BUSINESSES AT ALL STAGES OF GROWTH. THESE RESOURCES HELP REDUCE BARRIERS TO ENTRY, FACILITATE EXPANSION, AND ENCOURAGE INNOVATION WITHIN THE STATE'S ECONOMIC LANDSCAPE.

BUSINESS ATTRACTION AND RETENTION

THE DEPARTMENT ACTIVELY MARKETS CONNECTICUT AS A PRIME LOCATION FOR BUSINESS INVESTMENT, HIGHLIGHTING ITS

STRATEGIC LOCATION, SKILLED WORKFORCE, AND QUALITY OF LIFE. IT OFFERS PERSONALIZED ASSISTANCE TO COMPANIES CONSIDERING RELOCATION OR EXPANSION TO ENSURE A SMOOTH TRANSITION AND MAXIMIZE ECONOMIC BENEFITS.

TAX INCENTIVES AND CREDITS

VARIOUS TAX INCENTIVE PROGRAMS ARE AVAILABLE TO BUSINESSES THAT INVEST IN CONNECTICUT. THESE INCLUDE CREDITS FOR JOB CREATION, RESEARCH AND DEVELOPMENT ACTIVITIES, AND INVESTMENTS IN DESIGNATED ENTERPRISE ZONES. SUCH INCENTIVES ARE DESIGNED TO IMPROVE THE STATE'S COMPETITIVENESS AND ENCOURAGE LONG-TERM BUSINESS COMMITMENTS.

ACCESS TO CAPITAL

THE DECD FACILITATES ACCESS TO FINANCING THROUGH LOAN PROGRAMS AND PARTNERSHIPS WITH FINANCIAL INSTITUTIONS. THESE CAPITAL RESOURCES SUPPORT STARTUPS, SMALL BUSINESSES, AND LARGE ENTERPRISES BY PROVIDING AFFORDABLE FUNDING OPTIONS THAT MIGHT OTHERWISE BE UNAVAILABLE.

COMMUNITY DEVELOPMENT EFFORTS

BEYOND SUPPORTING BUSINESSES, THE CT DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT IS DEEPLY INVESTED IN ENHANCING THE SOCIAL AND ECONOMIC FABRIC OF COMMUNITIES ACROSS THE STATE. IT IMPLEMENTS PROGRAMS THAT ADDRESS HOUSING, INFRASTRUCTURE, AND PUBLIC AMENITIES TO CREATE VIBRANT AND SUSTAINABLE LOCALES.

AFFORDABLE HOUSING INITIATIVES

THE DEPARTMENT SUPPORTS THE DEVELOPMENT AND PRESERVATION OF AFFORDABLE HOUSING TO ENSURE THAT RESIDENTS HAVE ACCESS TO SAFE AND AFFORDABLE LIVING OPTIONS. THESE PROGRAMS OFTEN INCLUDE GRANTS, TAX CREDITS, AND TECHNICAL ASSISTANCE FOR DEVELOPERS AND MUNICIPALITIES.

INFRASTRUCTURE AND PUBLIC SPACE IMPROVEMENT

THIS SUPPORT HELPS TOWNS AND CITIES IMPLEMENT EFFECTIVE DEVELOPMENT STRATEGIES ALIGNED WITH BROADER STATE GOALS.

PARTNERSHIPS AND COLLABORATION
