WASTE COLLECTION SYSTEMS IN CRYSTAL LAKE

THE FOUNDATION OF CRYSTAL LAKE WASTE MANAGEMENT LIES IN EFFICIENT WASTE COLLECTION SYSTEMS DESIGNED TO HANDLE THE DIVERSE WASTE STREAMS GENERATED BY RESIDENTS AND BUSINESSES. THESE SYSTEMS INCLUDE CURBSIDE PICKUP, COMMERCIAL WASTE SERVICES, AND SPECIAL COLLECTION EVENTS FOR BULKY ITEMS OR YARD WASTE. THE CITY EMPLOYS A COMBINATION OF SCHEDULED AND ON-CALL SERVICES TO ENSURE TIMELY WASTE REMOVAL AND PREVENT ILLEGAL DUMPING.

RESIDENTIAL WASTE COLLECTION

RESIDENTIAL WASTE COLLECTION IN CRYSTAL LAKE IS ORGANIZED THROUGH WEEKLY CURBSIDE PICKUP PROGRAMS. PROPER SORTING AND CONTAMINATION PREVENTION ARE EMPHASIZED TO MAXIMIZE THE EFFECTIVENESS OF RECYCLING EFFORTS.

COMPOSTING AND ORGANIC WASTE MANAGEMENT
