THE DEPARTMENT IS STRUCTURED INTO VARIOUS DIVISIONS, EACH FOCUSING ON DIFFERENT ASPECTS SUCH AS BUSINESS ATTRACTION, INTERNATIONAL TRADE, TOURISM, AND COMMUNITY ASSISTANCE. ITS STRATEGIC OBJECTIVES INCLUDE INCREASING JOB OPPORTUNITIES, ENHANCING INFRASTRUCTURE, AND IMPROVING THE OVERALL ECONOMIC CLIMATE WITHIN CONNECTICUT.

ORGANIZATIONAL STRUCTURE

WORKFORCE DEVELOPMENT INITIATIVES
