GRANTS

GRANTS ARE TYPICALLY NEED-BASED FINANCIAL AID AWARDS THAT ALSO DO NOT REQUIRE REPAYMENT. COMMON GRANTS AVAILABLE TO FORT VALLEY STATE STUDENTS INCLUDE FEDERAL PELL GRANTS AND STATE-SPECIFIC GRANT PROGRAMS. THESE FUNDS HELP COVER ESSENTIAL EDUCATIONAL EXPENSES AND ARE AWARDED BASED ON THE STUDENT'S FINANCIAL SITUATION AS DETERMINED BY THE FAFSA.

LOANS

LOANS PROVIDE STUDENTS WITH FUNDS THAT MUST BE REPAID, USUALLY WITH INTEREST, AFTER GRADUATION OR UPON LEAVING SCHOOL. FORT VALLEY STATE UNIVERSITY FACILITATES ACCESS TO FEDERAL STUDENT LOANS SUCH AS DIRECT SUBSIDIZED AND UNSUBSIDIZED LOANS, AS WELL AS PARENT PLUS LOANS. UNDERSTANDING LOAN TERMS, INTEREST RATES, AND REPAYMENT OPTIONS IS CRITICAL FOR RESPONSIBLE BORROWING.

WORK-STUDY PROGRAMS

THE FEDERAL WORK-STUDY PROGRAM OFFERS PART-TIME EMPLOYMENT OPPORTUNITIES FOR STUDENTS TO EARN MONEY TO HELP PAY EDUCATIONAL EXPENSES. THESE POSITIONS MAY BE ON-CAMPUS OR COMMUNITY-BASED, PROVIDING VALUABLE WORK EXPERIENCE WHILE SUPPORTING STUDENTS FINANCIALLY.

ELIGIBILITY REQUIREMENTS AND APPLICATION PROCESS

FILING THE FAFSA

ACADEMIC AND ENROLLMENT REQUIREMENTS

ADDITIONAL DOCUMENTATION
