OVERVIEW OF THE FORTUNE SOCIETY

THE FORTUNE SOCIETY IS A WELL-ESTABLISHED NONPROFIT ORGANIZATION HEADQUARTERED IN NEW YORK CITY, WITH A SIGNIFICANT PRESENCE IN QUEENS, NEW YORK. FOUNDED IN 1967, ITS PRIMARY MISSION IS TO SUPPORT FORMERLY INCARCERATED INDIVIDUALS BY PROVIDING RESOURCES THAT FACILITATE SUCCESSFUL REENTRY INTO SOCIETY. THE ORGANIZATION'S NAME SYMBOLIZES HOPE AND OPPORTUNITY FOR THOSE SEEKING A NEW PATH AFTER INCARCERATION. OVER THE DECADES, THE FORTUNE SOCIETY HAS DEVELOPED A REPUTATION FOR OFFERING HOLISTIC, EVIDENCE-BASED SERVICES THAT ADDRESS VARIOUS BARRIERS FACED BY RETURNING CITIZENS.

HISTORY AND MISSION

THE FORTUNE SOCIETY STARTED AS A GRASSROOTS MOVEMENT BY A GROUP OF FORMERLY INCARCERATED INDIVIDUALS WHO RECOGNIZED THE NEED FOR COMPREHENSIVE SUPPORT UPON RELEASE. ITS MISSION EMPHASIZES DIGNITY, RESPECT, AND EMPOWERMENT FOR CLIENTS, FOCUSING ON REDUCING RECIDIVISM THROUGH EDUCATION, JOB PLACEMENT, HOUSING ASSISTANCE, AND COUNSELING. THE ORGANIZATION OPERATES WITH THE CONVICTION THAT STABLE HOUSING AND MEANINGFUL EMPLOYMENT ARE CRITICAL TO SUCCESSFUL REENTRY AND COMMUNITY SAFETY.

PRESENCE IN QUEENS, NEW YORK

THE FORTUNE SOCIETY'S QUEENS OFFICES PROVIDE LOCALIZED SERVICES TAILORED TO THE UNIQUE DEMOGRAPHIC AND SOCIO-ECONOMIC CHARACTERISTICS OF THE BOROUGH. QUEENS, BEING ONE OF NEW YORK CITY'S MOST DIVERSE COMMUNITIES, BENEFITS FROM THE ORGANIZATION'S CULTURALLY COMPETENT AND ACCESSIBLE PROGRAMS. THE QUEENS BRANCH ENSURES THAT INDIVIDUALS AFFECTED BY THE CRIMINAL JUSTICE SYSTEM RECEIVE NEIGHBORHOOD-SPECIFIC RESOURCES AND SUPPORT THAT ALIGN WITH THEIR NEEDS.

SERVICES OFFERED BY THE FORTUNE SOCIETY IN QUEENS

THE FORTUNE SOCIETY IN QUEENS DELIVERS A BROAD SPECTRUM OF SERVICES DESIGNED TO MEET THE MULTIFACETED NEEDS OF FORMERLY INCARCERATED INDIVIDUALS. THESE INCLUDE HOUSING PROGRAMS, EMPLOYMENT ASSISTANCE, EDUCATIONAL OPPORTUNITIES, HEALTH SERVICES, AND LEGAL SUPPORT. EACH SERVICE IS STRUCTURED TO REMOVE BARRIERS TO REINTEGRATION AND PROMOTE LONG-TERM STABILITY.

HOUSING ASSISTANCE PROGRAMS

ONE OF THE CORNERSTONE OFFERINGS OF THE FORTUNE SOCIETY IS HOUSING SUPPORT. THE ORGANIZATION PROVIDES TRANSITIONAL AND PERMANENT HOUSING SOLUTIONS, RECOGNIZING THAT STABLE HOUSING IS FOUNDATIONAL FOR SUCCESSFUL REENTRY. CLIENTS HAVE ACCESS TO SAFE, AFFORDABLE HOUSING OPTIONS IN QUEENS TAILORED TO DIFFERENT CIRCUMSTANCES, INCLUDING SINGLE ADULTS, FAMILIES, AND THOSE WITH SPECIAL NEEDS.

EMPLOYMENT AND JOB TRAINING

EMPLOYMENT SERVICES INCLUDE JOB READINESS TRAINING, RESUME DEVELOPMENT, INTERVIEW PREPARATION, AND DIRECT JOB PLACEMENT SUPPORT. THE FORTUNE SOCIETY IN QUEENS COLLABORATES WITH LOCAL EMPLOYERS TO CREATE PATHWAYS TO SUSTAINABLE EMPLOYMENT FOR ITS CLIENTS. TRAINING PROGRAMS FOCUS ON MARKETABLE SKILLS THAT ALIGN WITH CURRENT LABOR MARKET DEMANDS, FACILITATING ECONOMIC INDEPENDENCE.

EDUCATIONAL AND VOCATIONAL PROGRAMS

THE ORGANIZATION OFFERS EDUCATIONAL RESOURCES RANGING FROM GED PREPARATION TO COLLEGE ENROLLMENT ASSISTANCE. VOCATIONAL TRAINING PROGRAMS EQUIP CLIENTS WITH PRACTICAL SKILLS IN TRADES AND TECHNOLOGY SECTORS. THESE EDUCATIONAL INITIATIVES AIM TO ENHANCE CLIENTS' QUALIFICATIONS AND IMPROVE THEIR COMPETITIVENESS IN THE JOB MARKET.

COUNSELING AND SUPPORT SERVICES

COMPREHENSIVE COUNSELING SERVICES ADDRESS MENTAL HEALTH, SUBSTANCE USE, AND TRAUMA RECOVERY. THE FORTUNE SOCIETY PROVIDES INDIVIDUAL AND GROUP THERAPY SESSIONS, ENSURING CLIENTS HAVE EMOTIONAL AND PSYCHOLOGICAL SUPPORT DURING THEIR REINTEGRATION JOURNEY. CASE MANAGEMENT SERVICES HELP CLIENTS NAVIGATE SOCIAL SERVICES AND LEGAL CHALLENGES EFFECTIVELY.

IMPACT ON THE QUEENS COMMUNITY

THE FORTUNE SOCIETY'S WORK IN QUEENS HAS HAD A MEASURABLE IMPACT ON REDUCING RECIDIVISM RATES AND IMPROVING COMMUNITY SAFETY. BY OFFERING TAILORED SERVICES, THE ORGANIZATION HELPS FORMER INMATES BECOME PRODUCTIVE MEMBERS OF SOCIETY. ITS EFFORTS CONTRIBUTE TO BREAKING THE CYCLE OF INCARCERATION AND POVERTY THAT DISPROPORTIONATELY AFFECTS CERTAIN NEIGHBORHOODS IN QUEENS.

REDUCTION OF RECIDIVISM

STUDIES AND INTERNAL DATA INDICATE THAT CLIENTS ENGAGED WITH THE FORTUNE SOCIETY ARE SIGNIFICANTLY LESS LIKELY TO RETURN TO PRISON. THE COMPREHENSIVE SUPPORT SYSTEM ADDRESSES ROOT CAUSES OF CRIMINAL BEHAVIOR, FOSTERING STABILITY AND RESILIENCE. THIS SUCCESS BENEFITS THE BROADER QUEENS COMMUNITY THROUGH ENHANCED PUBLIC SAFETY AND REDUCED CRIMINAL JUSTICE COSTS.

COMMUNITY EMPOWERMENT AND INTEGRATION

THE FORTUNE SOCIETY PROMOTES COMMUNITY INTEGRATION BY FACILITATING SOCIAL CONNECTIONS AND CIVIC ENGAGEMENT AMONG CLIENTS. THE ORGANIZATION HOSTS EVENTS AND WORKSHOPS THAT ENCOURAGE POSITIVE INTERACTIONS BETWEEN FORMERLY INCARCERATED INDIVIDUALS AND LOCAL RESIDENTS, FOSTERING MUTUAL UNDERSTANDING AND REDUCING STIGMA.

COMMUNITY PARTNERSHIPS AND COLLABORATION

THE FORTUNE SOCIETY IN QUEENS COLLABORATES WITH VARIOUS GOVERNMENT AGENCIES, NONPROFITS, AND LOCAL BUSINESSES TO ENHANCE SERVICE DELIVERY. THESE PARTNERSHIPS EXPAND RESOURCES AND CREATE A NETWORK OF SUPPORT FOR CLIENTS, ENSURING A HOLISTIC APPROACH TO REENTRY.

GOVERNMENT AND PUBLIC SECTOR ALLIANCES

COORDINATION WITH CITY AND STATE AGENCIES ALLOWS THE FORTUNE SOCIETY TO SECURE FUNDING AND ACCESS SPECIALIZED PROGRAMS. THIS COLLABORATION ENSURES COMPLIANCE WITH REGULATIONS AND ALIGNMENT WITH PUBLIC POLICY GOALS RELATED TO CRIMINAL JUSTICE REFORM AND COMMUNITY DEVELOPMENT.

NONPROFIT AND COMMUNITY ORGANIZATION NETWORKS

The federal Fair Housing Act of 1968 was passed in a time of turmoil, conflict, and often conflagration in cities across the nation. It took the assassination of Dr. Martin Luther King, Jr. to finally secure its passage. The Kerner Commission warned in 1968 that to continue present policies is to make permanent the division of our country into two societies; one largely Negro and poor, located in the central cities; the other, predominantly white and affluent, located in the suburbs and outlying areas. The Fair Housing Act was passed with a dual mandate: to end discrimination and to dismantle the segregated living patterns that characterized most cities. The Fight for Fair Housing tells us what happened, why, and what remains to be done. Since the passage of the Fair Housing Act, the many forms of housing discrimination and segregation, and associated consequences, have been documented. At the same time, significant progress has been made in counteracting discrimination and promoting integration. Few suburbs today are all white; many people of color are moving to the suburbs; and some white families are moving back to the city. Unfortunately, discrimination and segregation persist. The Fight for Fair Housing brings together the nation's leading fair housing activists and scholars (many of whom are in both camps) to tell the stories that led to the passage of the Fair Housing Act, its consequences, and the implications of the act going forward. Including an afterword by Walter Mondale, this book is intended for everyone concerned with the future of our cities and equal access for all persons to housing and related opportunities.
