• OBC PwBD: Up to 45 years

SC/ST PwBD: Up to 47 years

Other Specific Relaxations

Additional relaxations apply to candidates such as defense service personnel and ex-servicemen. For instance, ex-servicemen are eligible for age relaxation up to 5 years beyond the prescribed limits.
