## UNDERSTANDING IADL ASSESSMENT IN OCCUPATIONAL THERAPY

IADL ASSESSMENT OCCUPATIONAL THERAPY FOCUSES ON EVALUATING AN INDIVIDUAL'S CAPABILITY TO PERFORM COMPLEX DAILY ACTIVITIES NECESSARY FOR INDEPENDENT LIVING. UNLIKE BASIC ACTIVITIES OF DAILY LIVING (ADLs), WHICH INCLUDE FUNDAMENTAL SELF-CARE TASKS, IADLs ENCOMPASS MORE SOPHISTICATED FUNCTIONS SUCH AS MANAGING FINANCES, SHOPPING, HOUSEKEEPING, AND USING TRANSPORTATION. OCCUPATIONAL THERAPISTS ASSESS THESE ACTIVITIES TO DETERMINE THE EXTENT TO WHICH A PERSON CAN SAFELY AND EFFECTIVELY MANAGE THEIR ENVIRONMENT AND MAINTAIN AUTONOMY.

THIS EVALUATION IS ESSENTIAL FOR POPULATIONS SUCH AS OLDER ADULTS, INDIVIDUALS RECOVERING FROM INJURY OR ILLNESS, AND PEOPLE WITH CHRONIC CONDITIONS AFFECTING COGNITIVE OR PHYSICAL FUNCTION. THROUGH IADL ASSESSMENT OCCUPATIONAL THERAPY, CLINICIANS CAN IDENTIFY BARRIERS TO INDEPENDENCE AND DESIGN INTERVENTIONS THAT PROMOTE SKILL ACQUISITION, ADAPTATION, OR COMPENSATION STRATEGIES.

## DEFINITION AND SCOPE OF IADLs

INSTRUMENTAL ACTIVITIES OF DAILY LIVING (IADLs) REFER TO TASKS THAT SUPPORT INDEPENDENT LIVING WITHIN A COMMUNITY. THESE ACTIVITIES REQUIRE HIGHER-LEVEL COGNITIVE, PHYSICAL, AND SOCIAL SKILLS COMPARED TO BASIC ADLs. IADLs TYPICALLY INCLUDE:

- MEAL PREPARATION AND COOKING
- MANAGING MONEY AND BUDGETING
- MEDICATION MANAGEMENT
- HOUSEKEEPING AND LAUNDRY
- USING TRANSPORTATION AND DRIVING
- SHOPPING FOR GROCERIES AND ESSENTIALS

- COMMUNICATION VIA TELEPHONE OR TECHNOLOGY

## ROLE OF OCCUPATIONAL THERAPY IN IADL ASSESSMENT

OCCUPATIONAL THERAPISTS ARE UNIQUELY QUALIFIED TO CONDUCT IADL ASSESSMENTS BECAUSE OF THEIR HOLISTIC APPROACH TO EVALUATING PHYSICAL, COGNITIVE, AND PSYCHOSOCIAL FACTORS AFFECTING DAILY FUNCTIONING. THEY USE STANDARDIZED AND NON-STANDARDIZED TOOLS TO ASSESS PERFORMANCE, SAFETY, AND INDEPENDENCE IN IADL TASKS. THE RESULTS INFORM THERAPEUTIC GOALS, ENVIRONMENTAL MODIFICATIONS, AND ASSISTIVE TECHNOLOGY RECOMMENDATIONS. OCCUPATIONAL THERAPY INTERVENTIONS AIM TO RESTORE OR ENHANCE IADL PERFORMANCE TO INCREASE OVERALL QUALITY OF LIFE AND REDUCE CAREGIVER BURDEN.

## COMPONENTS OF IADL ASSESSMENT

EFFECTIVE IADL ASSESSMENT OCCUPATIONAL THERAPY INVOLVES A MULTIDIMENSIONAL EVALUATION OF VARIOUS FACTORS INFLUENCING TASK PERFORMANCE. THESE COMPONENTS INCLUDE COGNITIVE ABILITIES, PHYSICAL FUNCTION, ENVIRONMENTAL CONTEXT, AND PSYCHOSOCIAL ASPECTS. UNDERSTANDING EACH COMPONENT ALLOWS FOR A COMPREHENSIVE APPRAISAL OF THE INDIVIDUAL'S STRENGTHS AND CHALLENGES.

### COGNITIVE EVALUATION

COGNITIVE FUNCTION IS CRITICAL IN PERFORMING IADLS AS TASKS OFTEN REQUIRE MEMORY, ATTENTION, PROBLEM-SOLVING, AND EXECUTIVE FUNCTIONING. OCCUPATIONAL THERAPISTS ASSESS COGNITIVE DOMAINS TO DETERMINE HOW IMPAIRMENTS MAY AFFECT AN INDIVIDUAL'S ABILITY TO PLAN, ORGANIZE, AND CARRY OUT COMPLEX TASKS SUCH AS MANAGING FINANCES OR MEDICATION SCHEDULES.

### PHYSICAL AND MOTOR SKILLS ASSESSMENT

PHYSICAL ABILITIES SUCH AS STRENGTH, COORDINATION, DEXTERITY, AND MOBILITY ARE NECESSARY FOR MANY IADLS. THE ASSESSMENT EVALUATES THE INDIVIDUAL'S CAPACITY TO PERFORM TASKS LIKE COOKING, CLEANING, AND TRANSPORTATION SAFELY AND EFFECTIVELY. LIMITATIONS IN MOTOR SKILLS MAY NECESSITATE ADAPTIVE EQUIPMENT OR ENVIRONMENTAL MODIFICATIONS.

### ENVIRONMENTAL AND SOCIAL CONTEXT

ENVIRONMENTAL FACTORS INCLUDING HOME LAYOUT, ACCESSIBILITY, AND SOCIAL SUPPORT INFLUENCE IADL PERFORMANCE. OCCUPATIONAL THERAPISTS CONSIDER THESE CONTEXTUAL ELEMENTS DURING ASSESSMENT TO IDENTIFY POTENTIAL BARRIERS OR FACILITATORS. SOCIAL FACTORS, SUCH AS THE AVAILABILITY OF CAREGIVERS OR COMMUNITY RESOURCES, ALSO PLAY A SIGNIFICANT ROLE IN INDEPENDENCE.

## COMMON TOOLS AND METHODS FOR IADL ASSESSMENT

SEVERAL STANDARDIZED TOOLS AND OBSERVATION METHODS ARE USED IN IADL ASSESSMENT OCCUPATIONAL THERAPY TO OBJECTIVELY MEASURE FUNCTIONAL ABILITIES. THESE TOOLS VARY IN FOCUS, COMPLEXITY, AND ADMINISTRATION TIME, ALLOWING THERAPISTS TO SELECT THE MOST APPROPRIATE FOR EACH CLINICAL SCENARIO.

# STANDARDIZED ASSESSMENT TOOLS

SOME WIDELY USED IADL ASSESSMENT INSTRUMENTS INCLUDE:

- **THE LAWTON INSTRUMENTAL ACTIVITIES OF DAILY LIVING SCALE:** MEASURES THE ABILITY TO PERFORM EIGHT IADL DOMAINS SUCH AS TELEPHONE USE, SHOPPING, AND MEDICATION MANAGEMENT. IT IS COMMONLY USED WITH OLDER ADULTS.
- **THE ASSESSMENT OF MOTOR AND PROCESS SKILLS (AMPS):** EVALUATES MOTOR AND PROCESS SKILLS DURING IADL TASKS THROUGH DIRECT OBSERVATION IN NATURAL CONTEXTS.
- **THE PERFORMANCE ASSESSMENT OF SELF-CARE SKILLS (PASS):** MEASURES FUNCTIONAL MOBILITY, ADLS, AND IADLS THROUGH STANDARDIZED TASKS.
- **THE KITCHEN TASK ASSESSMENT (KTA):** FOCUSES SPECIFICALLY ON MEAL PREPARATION SKILLS AND PROBLEM-SOLVING ABILITIES.

## NON-STANDARDIZED AND OBSERVATIONAL METHODS

IN ADDITION TO STANDARDIZED TOOLS, OCCUPATIONAL THERAPISTS USE CLINICAL OBSERVATIONS, INTERVIEWS, AND CAREGIVER REPORTS TO GATHER COMPREHENSIVE INFORMATION. THESE METHODS HELP CAPTURE REAL-WORLD PERFORMANCE AND CONTEXTUAL FACTORS THAT MAY NOT BE EVIDENT IN FORMAL TESTING ENVIRONMENTS.

## IMPORTANCE AND BENEFITS OF IADL ASSESSMENT

CONDUCTING IADL ASSESSMENT OCCUPATIONAL THERAPY PROVIDES CRITICAL INFORMATION THAT GUIDES CLINICAL DECISION-MAKING AND PROMOTES PATIENT-CENTERED CARE. THE BENEFITS EXTEND TO INDIVIDUALS, FAMILIES, AND HEALTHCARE SYSTEMS.

## ENHANCING PATIENT INDEPENDENCE AND SAFETY

IDENTIFYING DEFICITS IN IADL PERFORMANCE ENABLES THERAPISTS TO DEVELOP TARGETED INTERVENTIONS THAT ENHANCE INDEPENDENCE AND REDUCE RISKS SUCH AS FALLS, MEDICATION ERRORS, OR FINANCIAL EXPLOITATION. IMPROVING THESE SKILLS SUPPORTS SAFER COMMUNITY LIVING.

## INFORMING CARE PLANNING AND RESOURCE ALLOCATION

IADL ASSESSMENT RESULTS HELP DETERMINE THE LEVEL OF ASSISTANCE REQUIRED, FROM MINIMAL SUPPORT TO FULL-TIME CAREGIVING. THIS INFORMATION ASSISTS IN CARE PLANNING, DISCHARGE DECISIONS, AND CONNECTING PATIENTS WITH APPROPRIATE COMMUNITY RESOURCES OR ASSISTIVE TECHNOLOGIES.

## SUPPORTING REHABILITATION AND FUNCTIONAL RECOVERY

BY PINPOINTING SPECIFIC IMPAIRMENTS AFFECTING IADLS, OCCUPATIONAL THERAPY INTERVENTIONS CAN FOCUS ON SKILL RESTORATION, COMPENSATORY STRATEGIES, OR ENVIRONMENTAL MODIFICATIONS. THIS PERSONALIZED APPROACH OPTIMIZES REHABILITATION OUTCOMES AND PROMOTES FUNCTIONAL RECOVERY.

# CHALLENGES AND CONSIDERATIONS IN IADL ASSESSMENT

DESPITE THEIR IMPORTANCE, IADL ASSESSMENTS PRESENT SEVERAL CHALLENGES THAT OCCUPATIONAL THERAPISTS MUST CONSIDER TO ENSURE ACCURATE AND MEANINGFUL EVALUATIONS.

## CULTURAL AND SOCIOECONOMIC FACTORS

CULTURAL DIFFERENCES AND SOCIOECONOMIC STATUS INFLUENCE THE RELEVANCE AND PERFORMANCE OF CERTAIN IADLS. THERAPISTS MUST ADAPT ASSESSMENTS TO REFLECT THE INDIVIDUAL'S LIFESTYLE, VALUES, AND AVAILABLE RESOURCES TO AVOID BIAS AND ENSURE CULTURALLY COMPETENT CARE.

## VARIABILITY IN ASSESSMENT ENVIRONMENTS

PERFORMANCE MAY DIFFER BETWEEN CLINICAL SETTINGS AND THE INDIVIDUAL'S HOME ENVIRONMENT. WHENEVER POSSIBLE, IN-HOME ASSESSMENTS OR SIMULATIONS PROVIDE MORE ACCURATE REPRESENTATIONS OF FUNCTIONAL ABILITIES AND CHALLENGES.

## BALANCING STANDARDIZATION AND INDIVIDUALIZATION

STANDARDIZED TOOLS OFFER RELIABILITY BUT MAY NOT CAPTURE UNIQUE PERSONAL OR ENVIRONMENTAL FACTORS. COMBINING FORMAL ASSESSMENTS WITH PERSONALIZED OBSERVATIONS AND INTERVIEWS ENHANCES THE OVERALL UNDERSTANDING OF IADL CAPACITY.
