UNDERSTANDING ICD-10 CODING

ICD-10 CODING IS A SYSTEMATIC APPROACH TO CLASSIFYING AND CODING DIAGNOSES, SYMPTOMS, AND PROCEDURES RECORDED IN PATIENT MEDICAL RECORDS. INTRODUCED BY THE WORLD HEALTH ORGANIZATION (WHO), THE ICD-10 SYSTEM REPLACED THE EARLIER ICD-9 TO PROVIDE GREATER SPECIFICITY AND DETAIL IN CLINICAL CODING. ICD-10 CODING CONSISTS OF TWO MAIN PARTS: ICD-10-CM (CLINICAL MODIFICATION) USED FOR DIAGNOSIS CODING IN THE UNITED STATES, AND ICD-10-PCS (PROCEDURE CODING SYSTEM) USED PRIMARILY FOR INPATIENT HOSPITAL PROCEDURE CODING.

STRUCTURE OF ICD-10 CODES

ICD-10 CODES ARE ALPHANUMERIC AND STRUCTURED TO ALLOW DETAILED CLASSIFICATION OF DISEASES AND RELATED HEALTH PROBLEMS. ICD-10-CM CODES TYPICALLY BEGIN WITH A LETTER FOLLOWED BY NUMBERS, INDICATING THE CATEGORY, ETIOLOGY, ANATOMIC SITE, SEVERITY, AND OTHER CLINICAL DETAILS. ICD-10-PCS CODES, ON THE OTHER HAND, ARE COMPOSED OF SEVEN CHARACTERS THAT REPRESENT DIFFERENT ASPECTS OF A MEDICAL PROCEDURE, SUCH AS SECTION, BODY SYSTEM, ROOT OPERATION, AND APPROACH.

DIFFERENCES BETWEEN ICD-9 AND ICD-10

THE TRANSITION FROM ICD-9 TO ICD-10 CODING INTRODUCED SIGNIFICANT CHANGES, INCLUDING INCREASED CODE VOLUMES, ENHANCED SPECIFICITY, AND EXPANDED DATA CAPTURE CAPABILITIES.
