IDAHO OCCUPATIONAL THERAPY LICENSING AUTHORITY

THE IDAHO OCCUPATIONAL THERAPY LICENSE IS REGULATED BY THE IDAHO BOARD OF OCCUPATIONAL THERAPY PRACTICE. THIS REGULATORY BODY IS RESPONSIBLE FOR ISSUING LICENSES, ENFORCING STATE LAWS AND RULES ASSOCIATED WITH OCCUPATIONAL THERAPY, AND ENSURING THAT PRACTITIONERS ADHERE TO PROFESSIONAL STANDARDS. THE BOARD OPERATES UNDER THE IDAHO DIVISION OF OCCUPATIONAL AND PROFESSIONAL LICENSES AND AIMS TO PROTECT PUBLIC HEALTH AND SAFETY BY OVERSEEING COMPETENT AND ETHICAL OCCUPATIONAL THERAPY SERVICES.

ROLE OF THE BOARD

THE BOARD REVIEWS APPLICATIONS FOR LICENSURE, INVESTIGATES COMPLAINTS AGAINST LICENSED THERAPISTS, CONDUCTS DISCIPLINARY ACTIONS WHEN NECESSARY, AND ESTABLISHES CONTINUING EDUCATION REQUIREMENTS. IT ALSO UPDATES RULES TO REFLECT CHANGES IN OCCUPATIONAL THERAPY PRACTICE AND ENSURES COMPLIANCE WITH STATE STATUTES.

CONTACT INFORMATION AND RESOURCES

ELIGIBILITY REQUIREMENTS FOR LICENSURE

TO OBTAIN AN IDAHO OCCUPATIONAL THERAPY LICENSE, CANDIDATES MUST SATISFY SPECIFIC ELIGIBILITY CRITERIA

DEMONSTRATING THEIR QUALIFICATIONS AND READINESS TO PRACTICE SAFELY. THESE REQUIREMENTS ENSURE THAT ONLY COMPETENT AND ADEQUATELY TRAINED PROFESSIONALS ARE LICENSED IN THE STATE.

EDUCATIONAL CREDENTIALS

APPLICANTS MUST HOLD A DEGREE IN OCCUPATIONAL THERAPY FROM AN ACCREDITED EDUCATIONAL PROGRAM. TYPICALLY, THIS MEANS COMPLETING A MASTER'S OR DOCTORAL DEGREE IN OCCUPATIONAL THERAPY ACCREDITED BY THE ACCREDITATION COUNCIL FOR OCCUPATIONAL THERAPY EDUCATION (ACOTE).

EXAMINATION REQUIREMENTS

SUCCESSFUL COMPLETION OF THE NATIONAL BOARD FOR CERTIFICATION IN OCCUPATIONAL THERAPY (NBCOT) EXAMINATION IS MANDATORY. THIS EXAM ASSESSES THE CANDIDATE'S KNOWLEDGE AND SKILLS NECESSARY FOR ENTRY-LEVEL OCCUPATIONAL THERAPY PRACTICE.

BACKGROUND CHECK AND LEGAL REQUIREMENTS

APPLICANTS MUST UNDERGO A CRIMINAL BACKGROUND CHECK AS PART OF THE LICENSING PROCESS. ADDITIONALLY, THEY MUST PROVIDE PROOF OF LAWFUL PRESENCE IN THE UNITED STATES AND MEET ANY OTHER LEGAL REQUIREMENTS STIPULATED BY IDAHO STATE LAW.

- OFFICIAL TRANSCRIPTS FROM ACCREDITED OCCUPATIONAL THERAPY PROGRAMS
- PROOF OF PASSING THE NBCOT EXAMINATION
- VERIFICATION OF LICENSURE IF PREVIOUSLY LICENSED IN ANOTHER STATE
- RESULTS OF THE CRIMINAL BACKGROUND CHECK

APPLICATION REVIEW AND APPROVAL

AFTER RECEIVING ALL REQUIRED DOCUMENTS AND FEES, THE BOARD REVIEWS THE APPLICATION. THIS PROCESS MAY TAKE SEVERAL WEEKS DEPENDING ON THE COMPLETENESS OF THE SUBMISSION AND THE VOLUME OF APPLICATIONS. APPLICANTS ARE NOTIFIED UPON APPROVAL OR IF ADDITIONAL INFORMATION IS NEEDED.

LICENSE RENEWAL AND CONTINUING EDUCATION

MAINTAINING AN IDAHO OCCUPATIONAL THERAPY LICENSE REQUIRES PERIODIC RENEWAL AND COMPLETION OF CONTINUING EDUCATION TO KEEP SKILLS CURRENT AND ENSURE ONGOING COMPLIANCE WITH PROFESSIONAL STANDARDS.

RENEWAL FREQUENCY

LICENSES IN IDAHO MUST BE RENEWED EVERY TWO YEARS. RENEWAL NOTICES ARE TYPICALLY SENT IN ADVANCE TO REMIND LICENSEES OF UPCOMING DEADLINES.

CONTINUING EDUCATION REQUIREMENTS

LICENSEES ARE REQUIRED TO COMPLETE A MINIMUM OF 20 HOURS OF APPROVED CONTINUING EDUCATION DURING EACH RENEWAL CYCLE. THESE EDUCATIONAL ACTIVITIES MUST BE RELEVANT TO OCCUPATIONAL THERAPY PRACTICE AND APPROVED BY THE BOARD OR RECOGNIZED ACCREDITING ORGANIZATIONS.

RENEWAL APPLICATION PROCESS

TO RENEW THE LICENSE, PRACTITIONERS MUST SUBMIT A RENEWAL APPLICATION ALONG WITH PROOF OF COMPLETED CONTINUING EDUCATION AND PAY THE APPLICABLE RENEWAL FEE. FAILURE TO RENEW ON TIME MAY RESULT IN PENALTIES OR LICENSE SUSPENSION.

SCOPE OF PRACTICE AND PROFESSIONAL STANDARDS

THE IDAHO OCCUPATIONAL THERAPY LICENSE DEFINES THE SCOPE OF PRACTICE FOR OCCUPATIONAL THERAPISTS IN THE STATE, OUTLINING THE PROFESSIONAL ACTIVITIES THEY ARE AUTHORIZED TO PERFORM.

PERMITTED ACTIVITIES

LICENSED OCCUPATIONAL THERAPISTS IN IDAHO MAY EVALUATE, PLAN, AND IMPLEMENT THERAPEUTIC INTERVENTIONS THAT HELP INDIVIDUALS DEVELOP, RECOVER, OR MAINTAIN DAILY LIVING AND WORK SKILLS. THIS INCLUDES WORKING WITH PATIENTS ACROSS VARIOUS SETTINGS SUCH AS HOSPITALS, SCHOOLS, REHABILITATION CENTERS, AND PRIVATE PRACTICES.

ETHICAL AND PROFESSIONAL CONDUCT

LICENSE HOLDERS MUST ADHERE TO ETHICAL GUIDELINES ESTABLISHED BY THE BOARD AND PROFESSIONAL ORGANIZATIONS. THIS INCLUDES MAINTAINING PATIENT CONFIDENTIALITY, OBTAINING INFORMED CONSENT, AND PRACTICING WITHIN THE BOUNDS OF THEIR TRAINING AND COMPETENCY.

FEES AND PROCESSING TIMES

THE IDAHO OCCUPATIONAL THERAPY LICENSE APPLICATION AND RENEWAL PROCESSES INVOLVE SPECIFIC FEES AND EXPECTED PROCESSING TIMES THAT APPLICANTS SHOULD BE AWARE OF FOR PLANNING PURPOSES.

APPLICATION FEES

THE INITIAL APPLICATION FEE FOR LICENSURE IS REQUIRED AT THE TIME OF SUBMISSION. ADDITIONAL FEES MAY APPLY FOR BACKGROUND CHECKS AND VERIFICATION OF OUT-OF-STATE LICENSES.

RENEWAL FEES

LICENSE RENEWAL ALSO INCURS A FEE, WHICH MUST BE PAID ALONG WITH THE RENEWAL APPLICATION AND CONTINUING EDUCATION DOCUMENTATION.

TYPICAL PROCESSING TIMES

PROCESSING TIMES FOR NEW APPLICATIONS GENERALLY RANGE FROM TWO TO SIX WEEKS DEPENDING ON THE COMPLETENESS OF THE APPLICATION AND VERIFICATION PROCEDURES. RENEWALS ARE USUALLY PROCESSED MORE QUICKLY, OFTEN WITHIN TWO WEEKS OF RECEIPT.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE BASIC REQUIREMENTS TO OBTAIN AN OCCUPATIONAL THERAPY LICENSE IN IDAHO?

TO OBTAIN AN OCCUPATIONAL THERAPY LICENSE IN IDAHO, APPLICANTS MUST HAVE GRADUATED FROM AN ACCREDITED OCCUPATIONAL THERAPY PROGRAM, PASSED THE NATIONAL BOARD FOR CERTIFICATION IN OCCUPATIONAL THERAPY (NBCOT) EXAM, AND SUBMITTED AN APPLICATION WITH REQUIRED FEES TO THE IDAHO BOARD OF OCCUPATIONAL THERAPY PRACTICE.

HOW CAN I APPLY FOR AN IDAHO OCCUPATIONAL THERAPY LICENSE BY ENDORSEMENT?

TO APPLY FOR AN IDAHO OCCUPATIONAL THERAPY LICENSE BY ENDORSEMENT, APPLICANTS MUST HOLD A CURRENT, VALID OCCUPATIONAL THERAPY LICENSE IN ANOTHER STATE WITH REQUIREMENTS EQUIVALENT TO IDAHO'S, SUBMIT AN ENDORSEMENT APPLICATION, PROVIDE VERIFICATION OF LICENSURE, AND PAY THE APPLICABLE FEES TO THE IDAHO BOARD OF OCCUPATIONAL THERAPY PRACTICE.

WHAT IS THE RENEWAL PROCESS AND FREQUENCY FOR AN OCCUPATIONAL THERAPY LICENSE IN IDAHO?

IN IDAHO, OCCUPATIONAL THERAPY LICENSES MUST BE RENEWED EVERY TWO YEARS. LICENSEES ARE REQUIRED TO COMPLETE CONTINUING EDUCATION REQUIREMENTS AS SPECIFIED BY THE IDAHO BOARD OF OCCUPATIONAL THERAPY PRACTICE AND SUBMIT A RENEWAL APPLICATION ALONG WITH THE RENEWAL FEE BEFORE THE LICENSE EXPIRATION DATE.

ARE THERE SPECIFIC CONTINUING EDUCATION REQUIREMENTS TO MAINTAIN AN

OCCUPATIONAL THERAPY LICENSE IN IDAHO?

YES, LICENSED OCCUPATIONAL THERAPISTS IN IDAHO MUST COMPLETE A MINIMUM OF 20 HOURS OF CONTINUING EDUCATION DURING EACH TWO-YEAR LICENSURE PERIOD TO MAINTAIN THEIR LICENSE. THE CONTINUING EDUCATION ACTIVITIES MUST BE RELEVANT TO OCCUPATIONAL THERAPY PRACTICE AND APPROVED BY THE IDAHO BOARD OF OCCUPATIONAL THERAPY PRACTICE.
