YOU CAN APPLY FOR AN IDAHO TEACHING CERTIFICATE BY COMPLETING AN ONLINE APPLICATION THROUGH THE IDAHO DEPARTMENT OF EDUCATION'S CERTIFICATION PORTAL, SUBMITTING ALL REQUIRED DOCUMENTATION INCLUDING TRANSCRIPTS, EXAM SCORES, AND BACKGROUND CHECKS, AND PAYING THE APPLICABLE FEES.

WHAT TYPES OF EDUCATOR CERTIFICATES DOES THE IDAHO DEPARTMENT OF EDUCATION OFFER?

The Idaho Department of Education offers several types of educator certificates including Standard Certificates for classroom teachers, Provisional Certificates for those completing requirements, Specialist Certificates for specialized roles, and Substitute Certificates for substitute teaching.

HOW LONG IS AN IDAHO TEACHING CERTIFICATE VALID, AND HOW DO I RENEW IT?

AN IDAHO TEACHING CERTIFICATE IS TYPICALLY VALID FOR FIVE YEARS. TO RENEW, EDUCATORS MUST COMPLETE REQUIRED CONTINUING EDUCATION CREDITS OR PROFESSIONAL DEVELOPMENT AND SUBMIT A RENEWAL APPLICATION THROUGH THE IDAHO DEPARTMENT OF EDUCATION BEFORE THE CERTIFICATE EXPIRES.

CAN OUT-OF-STATE TEACHERS GET CERTIFIED IN IDAHO?

Idaho requires candidates to pass the Praxis content exams relevant to their teaching field and the Praxis Principles of Learning and Teaching (PLT) exam to demonstrate pedagogical knowledge, unless exempted by alternative pathways.
