

IDEM CONSTRUCTION STORMWATER GENERAL PERMIT

IDEM CONSTRUCTION STORMWATER GENERAL PERMIT IS A CRITICAL REGULATORY REQUIREMENT FOR CONSTRUCTION PROJECTS IN INDIANA AIMED AT CONTROLLING STORMWATER RUNOFF AND PROTECTING WATER QUALITY. THIS PERMIT, ADMINISTERED BY THE INDIANA DEPARTMENT OF ENVIRONMENTAL MANAGEMENT (IDEM), REGULATES DISCHARGES FROM CONSTRUCTION SITES TO PREVENT POLLUTION FROM SEDIMENT, DEBRIS, AND OTHER CONTAMINANTS. UNDERSTANDING THE SCOPE, APPLICATION PROCESS, COMPLIANCE OBLIGATIONS, AND BEST MANAGEMENT PRACTICES RELATED TO THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT IS ESSENTIAL FOR CONTRACTORS, DEVELOPERS, AND ENVIRONMENTAL PROFESSIONALS. THIS ARTICLE PROVIDES A COMPREHENSIVE OVERVIEW OF THE PERMIT'S REQUIREMENTS, INCLUDING ELIGIBILITY CRITERIA, PERMIT CONDITIONS, INSPECTION PROTOCOLS, AND ENVIRONMENTAL IMPACT MITIGATION STRATEGIES. OVERVIEW OF IDEM CONSTRUCTION STORMWATER GENERAL PERMIT

THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT IS A REGULATORY INSTRUMENT DESIGNED TO CONTROL STORMWATER DISCHARGES FROM CONSTRUCTION ACTIVITIES DISTURBING ONE OR MORE ACRES OF LAND, OR SMALLER SITES THAT ARE PART OF A LARGER COMMON PLAN OF DEVELOPMENT. THIS PERMIT IS PART OF THE NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PROGRAM AUTHORIZED UNDER THE CLEAN WATER ACT, WHICH AIMS TO REDUCE POLLUTANTS ENTERING WATER BODIES. THE PERMIT ENSURES THAT CONSTRUCTION SITES IMPLEMENT APPROPRIATE EROSION AND SEDIMENT CONTROLS AND COMPLY WITH ENVIRONMENTAL STANDARDS ESTABLISHED BY THE INDIANA DEPARTMENT OF ENVIRONMENTAL MANAGEMENT. BY REQUIRING PERMITS, IDEM HELPS TO MINIMIZE THE ENVIRONMENTAL IMPACTS OF CONSTRUCTION ACTIVITIES ON NEARBY RIVERS, LAKES, WETLANDS, AND GROUNDWATER.

ELIGIBILITY AND APPLICATION PROCESS

TO QUALIFY FOR COVERAGE UNDER THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT, APPLICANTS MUST MEET SPECIFIC ELIGIBILITY CRITERIA. TYPICALLY, THIS INCLUDES CONSTRUCTION PROJECTS DISTURBING ONE ACRE OR MORE OF LAND OR SMALLER SITES THAT ARE PART OF A LARGER DEVELOPMENT PLAN EXCEEDING ONE ACRE. CERTAIN PROJECTS, SUCH AS THOSE DISCHARGING INTO IMPAIRED WATERS OR INVOLVING INDUSTRIAL ACTIVITIES, MAY REQUIRE INDIVIDUAL PERMITS OR ADDITIONAL CONDITIONS.

APPLICATION SUBMISSION

THE APPLICATION PROCESS REQUIRES SUBMITTING A NOTICE OF INTENT (NOI) TO IDEM, WHICH OUTLINES THE PROJECT DETAILS, LOCATION, AND PROPOSED STORMWATER CONTROLS. THE NOI MUST BE SUBMITTED BEFORE COMMENCING CONSTRUCTION ACTIVITIES TO ENSURE TIMELY COVERAGE UNDER THE PERMIT. IDEM REVIEWS THE APPLICATION TO CONFIRM ELIGIBILITY AND COMPLIANCE WITH REGULATORY STANDARDS.

FEES AND TIMELINES

APPLICANTS ARE REQUIRED TO PAY A PROCESSING FEE WITH THEIR NOI SUBMISSION, WHICH VARIES BASED ON PROJECT SIZE AND SCOPE. IDEM TYPICALLY PROCESSES APPLICATIONS WITHIN A DESIGNATED PERIOD, ALLOWING CONSTRUCTION TO BEGIN ONCE PERMIT COVERAGE IS GRANTED. FAILURE TO OBTAIN THE PERMIT BEFORE STARTING WORK CAN RESULT IN ENFORCEMENT ACTIONS.

PERMIT REQUIREMENTS AND CONDITIONS

THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT SETS FORTH SPECIFIC REQUIREMENTS AND CONDITIONS THAT CONSTRUCTION SITE OPERATORS MUST FOLLOW TO MAINTAIN COMPLIANCE. THESE CONDITIONS AIM TO REDUCE SEDIMENT AND POLLUTANT DISCHARGES THROUGH PROPER SITE MANAGEMENT AND CONTROL MEASURES.

CONTROL MEASURES

OPERATORS ARE REQUIRED TO IMPLEMENT EROSION AND SEDIMENT CONTROLS SUCH AS SILT FENCES, SEDIMENT BASINS, AND STABILIZED CONSTRUCTION ENTRANCES. THESE CONTROLS HELP PREVENT SOIL EROSION AND CAPTURE SEDIMENT BEFORE STORMWATER LEAVES THE SITE. REGULAR MAINTENANCE OF THESE CONTROL MEASURES IS ESSENTIAL TO ENSURE EFFECTIVENESS THROUGHOUT THE CONSTRUCTION PERIOD.

WASTE MANAGEMENT

THE PERMIT ALSO MANDATES PROPER HANDLING AND DISPOSAL OF CONSTRUCTION MATERIALS, CHEMICALS, AND WASTE TO PREVENT CONTAMINATION OF STORMWATER RUNOFF. THIS INCLUDES STORING MATERIALS UNDER COVER, CONTROLLING LEAKS AND SPILLS, AND DISPOSING OF WASTE IN ACCORDANCE WITH ENVIRONMENTAL REGULATIONS.

STORMWATER POLLUTION PREVENTION PLAN (SWPPP)

A VITAL COMPONENT OF THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT IS THE DEVELOPMENT AND IMPLEMENTATION OF A STORMWATER POLLUTION PREVENTION PLAN (SWPPP). THE SWPPP OUTLINES THE SPECIFIC PRACTICES AND PROCEDURES TO MINIMIZE STORMWATER POLLUTION ASSOCIATED WITH THE CONSTRUCTION SITE.

SWPPP DEVELOPMENT

THE SWPPP MUST BE PREPARED PRIOR TO COMMENCING CONSTRUCTION AND INCLUDE DETAILED DESCRIPTIONS OF SITE CONDITIONS, POTENTIAL POLLUTANT SOURCES, AND PLANNED CONTROL MEASURES. IT SHOULD ALSO IDENTIFY RESPONSIBLE PERSONNEL AND PROCEDURES FOR SITE INSPECTIONS AND MAINTENANCE.

SWPPP IMPLEMENTATION AND UPDATES

CONSTRUCTION SITE OPERATORS ARE RESPONSIBLE FOR IMPLEMENTING THE SWPPP AND MAKING UPDATES AS SITE CONDITIONS CHANGE OR NEW CHALLENGES ARISE. THE PLAN SERVES AS A LIVING DOCUMENT GUIDING STORMWATER MANAGEMENT

THROUGHOUT THE PROJECT LIFECYCLE.

INSPECTION AND MONITORING PROCEDURES

TO ENSURE ONGOING COMPLIANCE WITH THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT, REGULAR INSPECTIONS AND MONITORING ARE REQUIRED. THESE ACTIVITIES HELP IDENTIFY POTENTIAL ISSUES AND VERIFY THAT CONTROL MEASURES ARE FUNCTIONING PROPERLY.

INSPECTION FREQUENCY

INSPECTIONS MUST BE CONDUCTED AT LEAST ONCE EVERY SEVEN CALENDAR DAYS AND WITHIN 24 HOURS FOLLOWING A STORM EVENT OF 0.5 INCHES OR GREATER. THESE FREQUENT REVIEWS ENABLE TIMELY DETECTION OF EROSION PROBLEMS OR CONTROL FAILURES.

MONITORING AND REPORTING

MONITORING INVOLVES VISUAL ASSESSMENTS OF SEDIMENT CONTROL EFFECTIVENESS AND DOCUMENTING ANY CORRECTIVE ACTIONS TAKEN. OPERATORS MUST MAINTAIN INSPECTION RECORDS AND SUBMIT PERIODIC REPORTS TO IDEM AS PART OF PERMIT COMPLIANCE.

BEST MANAGEMENT PRACTICES FOR COMPLIANCE

ADOPTING BEST MANAGEMENT PRACTICES (BMPs) IS ESSENTIAL FOR MEETING THE REQUIREMENTS OF THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT AND REDUCING ENVIRONMENTAL IMPACTS.

- **EROSION CONTROL:** USE OF MULCH, VEGETATION, AND EROSION CONTROL BLANKETS TO STABILIZE EXPOSED SOIL.
- **SEDIMENT CONTROL:** INSTALLATION OF SILT FENCES, SEDIMENT TRAPS, AND BASINS TO CAPTURE SEDIMENT-LADEN RUNOFF.
- **RUNOFF MANAGEMENT:** DESIGNING DIVERSION CHANNELS AND TEMPORARY DETENTION AREAS TO MANAGE STORMWATER FLOW.
- **GOOD HOUSEKEEPING:** PROPER STORAGE AND HANDLING OF MATERIALS, WASTE MINIMIZATION, AND SPILL PREVENTION.
- **TRAINING AND AWARENESS:** EDUCATING SITE PERSONNEL ON STORMWATER REGULATIONS AND BMP IMPLEMENTATION.

ENFORCEMENT AND PENALTIES

NON-COMPLIANCE WITH THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT CAN RESULT IN ENFORCEMENT ACTIONS, INCLUDING FINES, STOP-WORK ORDERS, OR LEGAL PROCEEDINGS. IDEM ACTIVELY MONITORS CONSTRUCTION SITES AND INVESTIGATES COMPLAINTS TO ENSURE ADHERENCE TO PERMIT CONDITIONS.

COMMON VIOLATIONS

TYPICAL VIOLATIONS INCLUDE FAILURE TO OBTAIN PERMIT COVERAGE BEFORE STARTING CONSTRUCTION, INADEQUATE EROSION

AND SEDIMENT CONTROLS, IMPROPER SWPPP IMPLEMENTATION, AND FAILURE TO CONDUCT REQUIRED INSPECTIONS.

PENALTIES AND REMEDIATION

PENALTIES FOR VIOLATIONS VARY DEPENDING ON SEVERITY AND DURATION BUT CAN INCLUDE MONETARY FINES AND MANDATORY CORRECTIVE MEASURES. PROMPT REMEDIATION AND COOPERATION WITH IDEM CAN MITIGATE PENALTIES AND RESTORE COMPLIANCE.

FREQUENTLY ASKED QUESTIONS

WHAT IS THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT?

THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT IS A PERMIT ISSUED BY THE INDIANA DEPARTMENT OF ENVIRONMENTAL MANAGEMENT THAT REGULATES STORMWATER DISCHARGES FROM CONSTRUCTION ACTIVITIES TO PROTECT WATER QUALITY.

WHO NEEDS TO OBTAIN THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT?

ANY CONSTRUCTION SITE DISTURBING ONE ACRE OR MORE OF LAND, OR SMALLER SITES THAT ARE PART OF A LARGER COMMON PLAN OF DEVELOPMENT, MUST OBTAIN THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT BEFORE STARTING WORK.

HOW DO I APPLY FOR THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT?

YOU CAN APPLY FOR THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT ONLINE THROUGH THE IDEM E-PERMITTING SYSTEM BY SUBMITTING A NOTICE OF INTENT (NOI) ALONG WITH THE REQUIRED SITE AND PROJECT INFORMATION.

WHAT ARE THE MAIN REQUIREMENTS OF THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT?

THE PERMIT REQUIRES THE DEVELOPMENT AND IMPLEMENTATION OF A STORMWATER POLLUTION PREVENTION PLAN (SWPPP), INSTALLATION OF BEST MANAGEMENT PRACTICES (BMPs), SITE INSPECTIONS, AND REGULAR REPORTING TO CONTROL SEDIMENT AND POLLUTANTS IN STORMWATER RUNOFF.

HOW LONG IS THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT VALID?

THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT IS TYPICALLY VALID FOR FIVE YEARS FROM THE DATE OF ISSUANCE, AFTER WHICH RENEWAL OR REAPPLICATION IS NECESSARY IF CONSTRUCTION ACTIVITIES CONTINUE.

WHAT IS A STORMWATER POLLUTION PREVENTION PLAN (SWPPP) UNDER THE IDEM PERMIT?

A SWPPP IS A DETAILED PLAN OUTLINING HOW A CONSTRUCTION SITE WILL MINIMIZE STORMWATER POLLUTION BY IMPLEMENTING BEST MANAGEMENT PRACTICES AND CONTROLLING SEDIMENT AND OTHER POLLUTANTS DURING CONSTRUCTION.

ARE THERE ANY FEES ASSOCIATED WITH THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT?

YES, THERE ARE FEES FOR APPLYING FOR THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT, WHICH VARY DEPENDING ON THE SIZE OF THE CONSTRUCTION SITE AND THE TYPE OF PERMIT APPLICATION.

WHAT HAPPENS IF A CONSTRUCTION SITE DOES NOT COMPLY WITH THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT?

NON-COMPLIANCE CAN RESULT IN ENFORCEMENT ACTIONS BY IDEM, INCLUDING FINES, STOP-WORK ORDERS, OR OTHER PENALTIES TO ENSURE PROTECTION OF WATER QUALITY.

CAN THE IDEM CONSTRUCTION STORMWATER GENERAL PERMIT REQUIREMENTS CHANGE?

YES, IDEM MAY UPDATE THE PERMIT REQUIREMENTS PERIODICALLY TO REFLECT CHANGES IN REGULATIONS, ENVIRONMENTAL STANDARDS, OR BEST MANAGEMENT PRACTICES, SO PERMIT HOLDERS SHOULD STAY INFORMED OF ANY UPDATES.
