

# IL COSMETOLOGY STATE BOARD TEST

## ELIGIBILITY REQUIREMENTS FOR THE ILLINOIS COSMETOLOGY STATE BOARD TEST

BEFORE ATTEMPTING THE IL COSMETOLOGY STATE BOARD TEST, CANDIDATES MUST MEET SPECIFIC ELIGIBILITY CRITERIA MANDATED BY THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION (IDFPR). THESE REQUIREMENTS ENSURE THAT CANDIDATES HAVE THE NECESSARY FOUNDATIONAL KNOWLEDGE AND PRACTICAL EXPERIENCE TO QUALIFY FOR LICENSURE.

### EDUCATION AND TRAINING PREREQUISITES

APPLICANTS MUST COMPLETE A STATE-APPROVED COSMETOLOGY PROGRAM, WHICH TYPICALLY INVOLVES A MINIMUM OF 1,500 HOURS OF TRAINING. ### AGE AND RESIDENCY REQUIREMENTS

APPLICANTS MUST BE AT LEAST 16 YEARS OLD TO QUALIFY FOR THE IL COSMETOLOGY STATE BOARD TEST. WHILE ILLINOIS RESIDENCY IS NOT ALWAYS MANDATORY, CANDIDATES SHOULD VERIFY ANY RECENT CHANGES TO RESIDENCY POLICIES OR ADDITIONAL STATE-SPECIFIC REQUIREMENTS DURING THE APPLICATION PROCESS.

# STRUCTURE AND CONTENT OF THE IL COSMETOLOGY STATE BOARD TEST

THE IL COSMETOLOGY STATE BOARD TEST CONSISTS OF BOTH WRITTEN AND PRACTICAL COMPONENTS DESIGNED TO COMPREHENSIVELY ASSESS A CANDIDATE'S THEORETICAL KNOWLEDGE AND HANDS-ON SKILLS. UNDERSTANDING THE TEST'S STRUCTURE AND CONTENT IS CRUCIAL FOR EFFECTIVE PREPARATION.

## WRITTEN EXAMINATION

## PRACTICAL EXAMINATION

THE PRACTICAL EXAM REQUIRES CANDIDATES TO DEMONSTRATE PROFICIENCY IN ESSENTIAL COSMETOLOGY TECHNIQUES.
