## QUESTION FORMAT

THE TEST TYPICALLY EMPLOYS A COMBINATION OF MULTIPLE-CHOICE, TRUE/FALSE, AND SHORT-ANSWER QUESTIONS. THIS FORMAT ASSESSES BOTH FACTUAL KNOWLEDGE AND CRITICAL THINKING RELATED TO CONSTITUTIONAL PRINCIPLES. THE NUMBER OF QUESTIONS AND TIME ALLOTTED MAY VARY BY SCHOOL DISTRICT, BUT TESTS USUALLY TAKE BETWEEN 30 TO 60 MINUTES TO COMPLETE.

## ADMINISTRATION AND SCORING GUIDELINES

THE ILLINOIS 8TH GRADE CONSTITUTION TEST REQUIREMENTS INCLUDE SPECIFIC GUIDELINES FOR TEST ADMINISTRATION AND SCORING TO MAINTAIN CONSISTENCY ACROSS SCHOOL DISTRICTS. STUDENTS WITH DISABILITIES OR SPECIAL EDUCATION NEEDS OFTEN RECEIVE ACCOMMODATIONS SUCH AS EXTENDED TIME, ALTERNATIVE TEST FORMATS, OR ASSISTANCE ACCORDING TO THEIR INDIVIDUALIZED EDUCATION PROGRAM (IEP) OR 504 PLAN. THESE MEASURES ENSURE EQUITABLE ACCESS TO FULFILL THE CONSTITUTION TEST REQUIREMENTS.

Chapter 7 is devoted to the author's family, i.e., life with his wife Marilyn and his sons Gregory and Alexander, plus his commentary on contemporary American society. His conservative world view, generated by his spiritual persona and behaviors of the progressive Soviet Union and its American followers, are illustrated by his letters to the news media during the 1950-2000 decades. The book carries a foreword by Dr. Gerasim Tikoff, a friend and retired cardiologist, and is illustrated by photographs from 19th century Russia and the author's life in Latvia, Germany and the U.S.
