Reticent by nature, he had minimal public-relations and public-speaking experience, save two years as a member of his hometown high school debate team. Kindly stated, O'Leary was probably the least bad choice to serve as White House/hospital spokesman to inform the world of the status of the wounded President Reagan, special agent Tim McCarthy, and press secretary Jim Brady.
