She and her Congressman are now going after the corporate criminals like the IRS went after Al Capone.. for tax evasion. She has their pseudo-Federal ID numbers. Whereas, there is no statute of limitations when you are able to show that they knew they were committing fraud. The IRS looks at a fraud case entirely differently. It can pursue any case where it can prove the company knew it was cheating, even if the underpayment was 20 years ago.
