EVIDENCE

EVIDENCE QUESTIONS TEST KNOWLEDGE OF THE RULES GOVERNING THE ADMISSIBILITY OF PROOF IN COURT, INCLUDING RELEVANCE, HEARSAY EXCEPTIONS, PRIVILEGES, AND WITNESS COMPETENCY. UNDERSTANDING EVIDENTIARY PRINCIPLES IS CRUCIAL FOR TRIAL PRACTICE.

REAL PROPERTY

UNDERSTANDING COMMON TRAPS
