HEALTH SERVICES PROVIDED

These services are designed for individuals of all ages and include both clinical and educational components. The department prioritizes accessibility and affordability to ensure that all residents can benefit from its offerings.

IMMUNIZATION PROGRAMS

IMMUNIZATIONS ARE A CORE SERVICE PROVIDED BY THE MCCRACKEN COUNTY HEALTH DEPT TO PROTECT THE COMMUNITY AGAINST VACCINE-PREVENTABLE DISEASES. THE DEPARTMENT OFFERS VACCINES FOR CHILDREN, ADULTS, AND SENIORS, INCLUDING THOSE FOR INFLUENZA, HEPATITIS, AND COVID-19. IMMUNIZATION CLINICS ARE HELD REGULARLY, AND APPOINTMENTS ARE AVAILABLE TO ACCOMMODATE VARYING SCHEDULES.

MATERNAL AND CHILD HEALTH SERVICES

Supporting mothers and children is a significant focus, with services such as prenatal care referrals, well-child exams, and nutrition counseling. These programs help ensure healthy pregnancies and early childhood development, reducing risks associated with maternal and infant health complications.

CHRONIC DISEASE PREVENTION AND MANAGEMENT

BEYOND DIRECT HEALTH SERVICES, THE MCCRACKEN COUNTY HEALTH DEPT IMPLEMENTS VARIOUS COMMUNITY-BASED PROGRAMS TO ADDRESS BROADER DETERMINANTS OF HEALTH. THESE INITIATIVES ENGAGE LOCAL RESIDENTS AND PARTNER ORGANIZATIONS TO PROMOTE HEALTHIER LIFESTYLES AND ENVIRONMENTS.

HEALTH EDUCATION AND OUTREACH

HEALTH EDUCATORS CONDUCT WORKSHOPS, SEMINARS, AND OUTREACH EVENTS TO INFORM THE PUBLIC ABOUT TOPICS SUCH AS NUTRITION, PHYSICAL ACTIVITY, TOBACCO CESSATION, AND MENTAL HEALTH. THESE PROGRAMS ARE DESIGNED TO EMPOWER INDIVIDUALS WITH KNOWLEDGE AND SKILLS FOR HEALTHIER LIVING.

SUBSTANCE ABUSE PREVENTION

THE DEPARTMENT COLLABORATES WITH REGIONAL AGENCIES TO COMBAT SUBSTANCE ABUSE THROUGH PREVENTION EDUCATION, COMMUNITY COALITIONS, AND SUPPORT RESOURCES. EFFORTS FOCUS ON REDUCING THE PREVALENCE OF DRUG AND ALCOHOL

EMERGENCY PREPAREDNESS AND RESPONSE

Preparedness initiatives ensure the community is ready to respond to public health emergencies, including natural disasters and disease outbreaks. The health dept develops response plans, conducts drills, and disseminates information to keep residents informed and safe during crises.

ENVIRONMENTAL AND PUBLIC SAFETY EFFORTS

PROTECTING THE ENVIRONMENT AND ENSURING PUBLIC SAFETY ARE ESSENTIAL FUNCTIONS OF THE MCCRACKEN COUNTY HEALTH DEPT. ITS ENVIRONMENTAL HEALTH DIVISION ENFORCES REGULATIONS AND CONDUCTS INSPECTIONS TO PREVENT HAZARDS THAT COULD IMPACT HEALTH.

FOOD SERVICE INSPECTIONS

REGULAR INSPECTIONS OF RESTAURANTS, GROCERY STORES, AND OTHER FOOD ESTABLISHMENTS HELP MAINTAIN SANITARY CONDITIONS AND PREVENT FOODBORNE ILLNESSES. THE DEPARTMENT ENFORCES COMPLIANCE WITH STATE AND LOCAL HEALTH CODES, ISSUING PERMITS AND CORRECTIVE ACTIONS AS NEEDED.

WATER QUALITY AND SANITATION

THE HEALTH DEPT MONITORS PUBLIC AND PRIVATE WATER SOURCES TO ENSURE SAFE DRINKING WATER. IT ALSO OVERSEES WASTE DISPOSAL AND SANITATION SYSTEMS TO PREVENT CONTAMINATION AND PROTECT COMMUNITY HEALTH.

VECTOR CONTROL

EFFORTS TO CONTROL VECTORS SUCH AS MOSQUITOES AND RODENTS REDUCE THE RISK OF VECTOR-BORNE DISEASES. THE DEPARTMENT CONDUCTS SURVEILLANCE AND IMPLEMENTS CONTROL MEASURES, INCLUDING PUBLIC EDUCATION ON REDUCING BREEDING SITES.
