TYPES OF COMMERCIAL DRIVER'S LICENSES

THE MD MVA CDL MANUAL EXPLAINS THE VARIOUS CLASSES AND ENDORSEMENTS OF COMMERCIAL DRIVER'S LICENSES AVAILABLE IN MARYLAND. UNDERSTANDING THESE LICENSE TYPES IS CRITICAL FOR APPLICANTS TO IDENTIFY WHICH CDL SUITS THEIR INTENDED COMMERCIAL DRIVING ACTIVITIES.

CDL CLASSES

MARYLAND ISSUES THREE PRIMARY CLASSES OF CDLS BASED ON VEHICLE WEIGHT AND TYPE:

- **CLASS A:** AUTHORIZES DRIVING COMBINATION VEHICLES WITH A GROSS COMBINATION WEIGHT RATING (GCWR) OF 26,001 POUNDS OR MORE, PROVIDED THE TOWED VEHICLE EXCEEDS 10,000 POUNDS.
- **CLASS B:** PERMITS OPERATION OF A SINGLE VEHICLE WITH A GVWR OF 26,001 POUNDS OR MORE, OR TOWING A

VEHICLE NOT EXCEEDING 10,000 POUNDS.

- **CLASS C:** COVERS VEHICLES DESIGNED TO TRANSPORT 16 OR MORE PASSENGERS (INCLUDING THE DRIVER) OR HAZARDOUS MATERIALS REQUIRING PLACARDS, WHEN NEITHER CLASS A NOR B APPLIES.

ENDORSEMENTS AND RESTRICTIONS

ENDORSEMENTS ARE ADDITIONAL AUTHORIZATIONS THAT ALLOW CDL HOLDERS TO OPERATE SPECIALIZED VEHICLES OR TRANSPORT SPECIFIC TYPES OF CARGO. COMMON ENDORSEMENTS DESCRIBED IN THE MANUAL INCLUDE:

- **T:** DOUBLE/TRIPLE TRAILERS
- **P:** PASSENGER VEHICLES
- **N:** TANK VEHICLES
- **H:** HAZARDOUS MATERIALS
- **X:** COMBINATION OF TANK VEHICLE AND HAZARDOUS MATERIALS

CONVERSELY, RESTRICTIONS MAY LIMIT THE LICENSE HOLDER'S DRIVING PRIVILEGES, SUCH AS PROHIBITING AIR BRAKE-EQUIPPED VEHICLES IF THE DRIVER HAS NOT PASSED THE AIR BRAKES TEST.

REQUIREMENTS FOR OBTAINING A CDL IN MARYLAND

THE MD MVA CDL MANUAL OUTLINES SPECIFIC ELIGIBILITY CRITERIA AND DOCUMENTATION NECESSARY FOR OBTAINING A COMMERCIAL DRIVER'S LICENSE IN MARYLAND. PROSPECTIVE CDL APPLICANTS MUST MEET THESE REQUIREMENTS BEFORE APPLYING.

BASIC ELIGIBILITY

TO QUALIFY FOR A MARYLAND CDL, APPLICANTS MUST:

- BE AT LEAST 18 YEARS OLD FOR INTRASTATE DRIVING OR 21 YEARS OLD FOR INTERSTATE DRIVING
- POSSESS A VALID MARYLAND DRIVER'S LICENSE
- PROVIDE PROOF OF U.S. CITIZENSHIP OR LAWFUL PERMANENT RESIDENCY
- PASS A MEDICAL EXAMINATION AND OBTAIN A MEDICAL EXAMINER'S CERTIFICATE
- SUBMIT TO A BACKGROUND CHECK IF APPLYING FOR A HAZARDOUS MATERIALS ENDORSEMENT

APPLICATION PROCESS

THE PROCESS INVOLVES SUBMITTING THE CDL APPLICATION THROUGH AN MVA OFFICE, PASSING THE WRITTEN KNOWLEDGE TEST, COMPLETING THE SKILLS TEST, AND PAYING ALL APPLICABLE FEES. THE MANUAL DETAILS THE FORMS AND IDENTIFICATION DOCUMENTS REQUIRED, INCLUDING EVIDENCE OF RESIDENCY AND SOCIAL SECURITY NUMBER VERIFICATION.
