## INDICATORS OF POLITICAL APATHY

PSYCHOLOGICAL FATIGUE AND INFORMATION OVERLOAD FROM THE CONSTANT FLOW OF POLITICAL NEWS CAN ALSO CONTRIBUTE TO DISENGAGEMENT.

## STRUCTURAL AND INSTITUTIONAL CAUSES

POLITICAL APATHY IS FURTHER INFLUENCED BY INSTITUTIONAL BARRIERS AND SYSTEMIC ISSUES SUCH AS:

- COMPLEX OR INACCESSIBLE VOTING PROCEDURES
- LACK OF COMPETITIVE ELECTIONS OR DOMINANT PARTY SYSTEMS

## SOCIAL AND CULTURAL IMPLICATIONS
