**Humanitarianism** Anne Meike Fechter, Anke Schwittay, 2021-05-13 Citizen Aid and Everyday Humanitarianism brings together, under the umbrella terms of citizen aid and grassroots humanitarianism, interdisciplinary research on small-scale, privately-funded forms of aid that

operate on the margins of the official development sector. The last decade has seen a steady rise of such activities in the Global South and North, such as in response to the influx of refugees into Europe. The chapters in this volume cover a variety of locations in Asia, Africa and Europe, presenting empirically grounded cases of citizen aid. They range from educational development projects, to post-disaster emergency relief. Importantly, while some activities are initiated by Northern citizens, others are based on South-South assistance, such as Bangladeshi nationals supporting Rohingya refugees, and peer support in the Philippines in the aftermath of typhoon Haiyan. Together, the contributions consider citizen aid vis-à-vis more institutionalised forms of aid, review methodological approaches and their challenges and query the political dimensions of these initiatives. Key themes are historical perspectives on 'demotic humanitarianism', questions of legitimacy and professionalisation, founders' motivations, the role of personal connections, and the importance of digital media for brokerage and fundraising. Being mindful of the power imbalances inherent in citizen aid and everyday humanitarianism, they suggest that both deserve more systematic attention. Citizen Aid and Everyday Humanitarianism will be of great interest to scholars and professionals working in international development, humanitarianism, international aid and anthropology. **posner center for international development:** **The Implementation Game** Carolyn Deere, 2011-06-16 With the launch of the World Trade Organization (WTO) in 1995, its Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS) emerged as a symbol of coercion in international economic relations. In the decade that followed, intellectual property became one of the most contentious topics of global policy debate. This book is the first full-length study of the politics surrounding what developing countries did to implement TRIPS and why. Based on a review

of the evidence from 1995 to 2007, this book emphasises that developing countries exhibited considerable variation in their approach to TRIPS implementation. In particular, developing countries took varying degrees of advantage of the legal safeguards and options-commonly known as TRIPS 'flexibilities'-that the Agreement provides. To explain this variation, this book argues that TRIPS implementation must be understood as a complex political game played out among developing country governments and a range of stakeholders-developed countries, non-governmental organisations (NGOs), intergovernmental organisations (IGOs), and industry groups. The contested nature of the TRIPS bargain spurred competing efforts to revise the terms of TRIPS and to influence global IP regulation more broadly. The intensity of the implementation game was amplified by an awareness among the various stakeholders that the IP reforms developing countries pursued would influence these ongoing international negotiations. The book attributes the variation in TRIPS implementation to the interplay between these global IP debates, international power pressures, and political dynamics within developing countries. The book includes historical analysis, compilations of evidence, and analysis supported by examples from across the developing world. The Implementation Game will be of interest both to scholars of international relations, law, and international political economy as well as to policymakers, commentators, and activists engaged in debates on the global governance of intellectual property.

Efforts at coordination between nations are at the heart of the challenges of globalization. Despite steadily growing interdependencies, individual nations still have specific interests that present obstacles to globalization. While some challenges inspired by the need to coordinate are viewed as inevitable by many, they are less optimistic about prospects for success. Jan-Erik Lane argues that one should focus objectively upon the possibility of failures. Lane analyzes four kinds of challenges to interdependency, all of which are growing in geopolitical relevance. First, countries need to diminish their dependency on fossil fuel and shift to a reliable supply of energy, because fossil fuels are diminishing. Second, environmental degradation must be addressed, because it is accelerating under the strain of earth's population. Lane advocates an ecological footprint approach. Third, a single global market economy and its complexities must be addressed, as national economies are increasingly opened. Finally, as traditional state sovereignty weakens, foreign military intervention in both international and intra-state conflicts increases. Governments are attempting to address these interdependencies, or reply to the challenges they pose, mainly through international organizations and regionalism. These efforts are discussed at length. In addition, problems with international law are reviewed, as Lane warns against the utopian hopes of global constitutionalism. Globalization also examines the potential consequences of failing to address the need for coordination in efforts to address shared global challenges.

Chandler, 2014-05 This edited book sets out and engages with some of the key policies, practices and paradigms of external intervention in the case of state support and reconstruction. Many assumptions about statebuilding have been reconsidered in the wake of Iraq, and ongoing problems in other states such as Afghanistan, Bosnia and Kosovo. Rather than being a regional survey or a policy-orientated 'lessons learned' book, this collection explores the broader framing of policy goals, statebuilding practices and the consensus on the need for Western states and international institutions to be engaged in this policy area.
