ACCURATE ENTRIES WITH HONEST NOTES ABOUT STRENGTHS AND WEAKNESSES PROVIDE VALUABLE FEEDBACK FOR IMPROVING DRIVING SKILLS. DO NOT EXAGGERATE HOURS OR OMIT CHALLENGING CONDITIONS, AS THIS COULD HINDER PREPARATION FOR REAL-WORLD DRIVING.

UPDATE THE LOG PROMPTLY

RECORDING DETAILS IMMEDIATELY AFTER EACH SESSION HELPS AVOID FORGETTING KEY INFORMATION. USING A DEDICATED NOTEBOOK OR DIGITAL APP CAN FACILITATE TIMELY UPDATES AND ORGANIZATION.

INCLUDE A VARIETY OF DRIVING CONDITIONS

To meet licensing criteria and develop versatile driving skills, log entries should reflect practice in different conditions such as night driving, rain, highways, and busy urban areas. Supervisors should plan sessions accordingly.

KEEP THE LOG SECURE AND ACCESSIBLE
