UNDERSTANDING TAMPERING WITH PHYSICAL EVIDENCE IN KENTUCKY

HOW TAMPERING AFFECTS LEGAL PROCEEDINGS

WHEN EVIDENCE IS TAMPERED WITH, IT CAN HINDER LAW ENFORCEMENT'S ABILITY TO SOLVE CRIMES AND PROSECUTORS' CAPACITY TO PROVE CASES BEYOND A REASONABLE DOUBT. COURTS MAY EXCLUDE TAINTED EVIDENCE OR IMPOSE SANCTIONS ON PARTIES RESPONSIBLE FOR TAMPERING. THE OVERALL EFFECT IS A DIMINISHED TRUST IN THE JUDICIAL SYSTEM AND POTENTIAL MISCARRIAGE OF JUSTICE.

LEGAL DEFINITIONS AND STATUTORY PROVISIONS

EXAMPLES OF TAMPERING WITH EVIDENCE

FOR INSTANCE, A PERSON CHARGED WITH THEFT MIGHT DISPOSE OF STOLEN PROPERTY TO AVOID DETECTION, OR A SUSPECT IN A DRUG CASE COULD DESTROY DRUG PARAPHERNALIA BEFORE POLICE ARRIVE. BOTH ACTIONS WOULD CONSTITUTE TAMPERING

UNDER KENTUCKY LAW.

PENALTIES AND LEGAL CONSEQUENCES

CONVICTION FOR TAMPERING WITH PHYSICAL EVIDENCE KY CARRIES SIGNIFICANT LEGAL CONSEQUENCES THAT CAN AFFECT AN INDIVIDUAL'S CRIMINAL RECORD, LIBERTY, AND FUTURE OPPORTUNITIES.

CLASSIFICATION OF THE OFFENSE
