OVERVIEW OF THE TAMU MINOR IN BUSINESS

THE TAMU MINOR IN BUSINESS IS A STRUCTURED PROGRAM THAT INTRODUCES STUDENTS TO CORE BUSINESS CONCEPTS IN A COMPREHENSIVE MANNER. IT IS AIMED AT NON-BUSINESS MAJORS SEEKING TO SUPPLEMENT THEIR PRIMARY FIELD OF STUDY WITH FUNDAMENTAL BUSINESS KNOWLEDGE. THIS MINOR ENCOMPASSES KEY AREAS INCLUDING ACCOUNTING, MARKETING, ECONOMICS, MANAGEMENT, AND FINANCE, PROVIDING STUDENTS WITH A WELL-ROUNDED UNDERSTANDING OF HOW BUSINESSES OPERATE. THE MINOR IS TYPICALLY COMPLETED ALONGSIDE A STUDENT'S MAJOR COURSEWORK, ALLOWING FOR INTERDISCIPLINARY LEARNING THAT ENHANCES BOTH ACADEMIC AND PROFESSIONAL DEVELOPMENT. TEXAS A&M'S BUSINESS MINOR PROGRAM IS RECOGNIZED FOR ITS RIGOROUS CURRICULUM AND PRACTICAL APPROACH, PREPARING STUDENTS TO NAVIGATE THE COMPLEXITIES OF THE BUSINESS WORLD EFFECTIVELY.

PROGRAM OBJECTIVES

THE OBJECTIVES OF THE TAMU MINOR IN BUSINESS FOCUS ON EQUIPPING STUDENTS WITH ANALYTICAL AND DECISION-MAKING SKILLS RELEVANT TO BUSINESS ENVIRONMENTS. STUDENTS LEARN TO INTERPRET FINANCIAL INFORMATION, UNDERSTAND MARKET DYNAMICS, MANAGE ORGANIZATIONAL RESOURCES, AND DEVELOP STRATEGIC THINKING ABILITIES. THE PROGRAM AIMS TO FOSTER CRITICAL THINKING, ETHICAL REASONING, AND EFFECTIVE COMMUNICATION, ALL CRUCIAL FOR BUSINESS SUCCESS.

ELIGIBILITY AND ADMISSION REQUIREMENTS

ADMISSION TO THE TAMU MINOR IN BUSINESS REQUIRES STUDENTS TO MEET SPECIFIC ELIGIBILITY CRITERIA ESTABLISHED BY TEXAS A&M UNIVERSITY. GENERALLY, THE MINOR IS OPEN TO UNDERGRADUATE STUDENTS ENROLLED IN NON-BUSINESS MAJORS WHO DEMONSTRATE A STRONG ACADEMIC RECORD. MEETING CERTAIN GPA REQUIREMENTS AND COMPLETING PREREQUISITE COURSES MAY BE NECESSARY BEFORE OFFICIALLY DECLARING THE MINOR. THE APPLICATION PROCESS TYPICALLY INVOLVES SUBMITTING A FORMAL REQUEST THROUGH THE UNIVERSITY'S ACADEMIC ADVISING SYSTEM OR THE BUSINESS DEPARTMENT.

PREREQUISITES AND GPA STANDARDS

STUDENTS INTERESTED IN PURSUING THE MINOR MUST OFTEN COMPLETE FOUNDATIONAL COURSES SUCH AS INTRODUCTORY ECONOMICS OR MATHEMATICS TO ENSURE READINESS FOR BUSINESS COURSEWORK. A MINIMUM GPA, USUALLY AROUND 2.5 TO 3.0, IS COMMONLY REQUIRED TO MAINTAIN ELIGIBILITY. THESE STANDARDS ENSURE THAT STUDENTS ARE PREPARED TO HANDLE THE ACADEMIC RIGOR OF THE BUSINESS MINOR CURRICULUM.

CURRICULUM AND COURSE STRUCTURE

WHAT ARE THE CORE COURSES REQUIRED FOR THE TAMU MINOR IN BUSINESS?

THE CORE COURSES TYPICALLY INCLUDE PRINCIPLES OF MARKETING, FINANCE, MANAGEMENT, AND ACCOUNTING, ALONG WITH A FEW ELECTIVE BUSINESS COURSES, TOTALING AROUND 15-18 CREDIT HOURS.

HOW CAN THE TAMU MINOR IN BUSINESS BENEFIT NON-BUSINESS MAJORS?

HOW DO I APPLY FOR THE TAMU MINOR IN BUSINESS?

STUDENTS MUST APPLY THROUGH THE MAYS BUSINESS SCHOOL'S MINOR PROGRAM APPLICATION PROCESS, WHICH TYPICALLY INVOLVES SUBMITTING AN APPLICATION FORM, MEETING PREREQUISITES, AND OBTAINING ADVISOR APPROVAL.
