#### POSITIVE IMPACT ON INMATE REHABILITATION

VOLUNTEERS PLAY A CRUCIAL ROLE IN SUPPORTING INMATE REHABILITATION BY PROVIDING EDUCATIONAL, SPIRITUAL, AND EMOTIONAL RESOURCES. THEIR INVOLVEMENT HELPS REDUCE RECIDIVISM AND PROMOTES SUCCESSFUL REINTEGRATION INTO SOCIETY.

### BEST PRACTICES FOR SUCCESSFUL VOLUNTEERING

Ongoing education and flexibility allow volunteers to adapt to changes in policies or inmate needs. Participating in refresher courses and staying informed about TDCJ updates strengthens volunteer contributions over time.

These humanitarians help the Department meet the educational, socio-economic, and religious traditions and backgrounds of inmates, offenders, and staff, as well as many other societal conforming and principled ways to help improve their lives. Volunteer involvement provides additional resources, and enhances inmate/offender programs and services. It plays an important role in community transition and continuum efforts, creating opportunities for a greater public understanding of the challenges of Florida Department of Corrections (FDC).
