### UNDERSTANDING TAX ASSESSMENT IN LAKE COUNTY

THE ASSESSOR'S ROLE IS VITAL IN MAINTAINING AN EQUITABLE TAX SYSTEM AND PROVIDING TRANSPARENCY FOR TAXPAYERS.

### FUNCTIONS OF THE ASSESSOR'S OFFICE

## ASSESSMENT PROCESS AND SCHEDULES

### NOTICE OF ASSESSMENT

ONCE A PROPERTY IS ASSESSED, THE OWNER RECEIVES A NOTICE OF ASSESSMENT DETAILING THE NEW VALUE AND HOW IT WAS CALCULATED. THIS NOTICE IS AN IMPORTANT DOCUMENT FOR PROPERTY OWNERS TO REVIEW, AS IT SERVES AS THE BASIS FOR PROPERTY TAX BILLS ISSUED LATER IN THE YEAR.

#### FACTORS AFFECTING ASSESSMENT

SEVERAL FACTORS INFLUENCE THE ASSESSED VALUE, INCLUDING:

- RECENT SALES OF COMPARABLE PROPERTIES IN THE AREA
- PROPERTY SIZE, LOCATION, AND CONDITION
- IMPROVEMENTS OR ADDITIONS TO THE PROPERTY

#### STEPS IN THE APPEAL PROCESS

- 1. REVIEW THE NOTICE OF ASSESSMENT AND GATHER EVIDENCE SUCH AS RECENT APPRAISALS OR COMPARABLE SALES DATA.
- 2. CONTACT THE ASSESSOR'S OFFICE FOR A REVIEW OR INFORMAL DISCUSSION ABOUT THE ASSESSMENT.
- 3. FILE A FORMAL APPEAL WITH THE LAKE COUNTY BOARD OF REVIEW BY THE SPECIFIED DEADLINE.

- 4. ATTEND A HEARING WHERE EVIDENCE IS PRESENTED AND EVALUATED.
- 5. Receive a decision and, if necessary, pursue further appeals through the Illinois Property Tax Appeal Board or circuit court.

### IMPORTANT CONSIDERATIONS

APPEALS MUST BE TIMELY AND SUPPORTED BY FACTUAL EVIDENCE TO BE SUCCESSFUL. PROPERTY OWNERS SHOULD KEEP DETAILED RECORDS AND CONSIDER CONSULTING WITH TAX PROFESSIONALS OR ATTORNEYS SPECIALIZING IN PROPERTY TAX LAW IF NEEDED.

### CALCULATING PROPERTY TAXES IN LAKE COUNTY

After her conversion, she traveled with her family and other converts from the region to Nauvoo, Illinois, where the LDS church was then based. There, she took a job as a servant in the home of Joseph Smith, the founder and first prophet of the LDS church. When Smith was killed in 1844, Jane found employment as a servant in Brigham Young's home. These positions placed Jane in proximity to Mormonism's most powerful figures, but did not protect her from the church's racially discriminatory policies.

Nevertheless, she remained a faithful member until her death in 1908. Your Sister in the Gospel is the first scholarly biography of Jane Manning James or, for that matter, any black Mormon. Quincy D.
