HOSPITAL PATERNITY TESTING: AVAILABILITY AND PROTOCOLS

MANY INDIVIDUALS SEEKING TO ESTABLISH PATERNITY WONDER IF A HOSPITAL WILL PERFORM A PATERNITY TEST. THE AVAILABILITY OF PATERNITY TESTING IN HOSPITALS DEPENDS LARGELY ON THE HOSPITAL'S POLICIES, THE REASON FOR THE TEST, AND THE TIMING. GENERALLY, HOSPITALS MAY OFFER PATERNITY TESTING SERVICES IN THE CONTEXT OF NEWBORN CARE, ESPECIALLY WHEN LEGAL DOCUMENTATION OF PARENTAGE IS REQUIRED SHORTLY AFTER BIRTH. HOWEVER, ROUTINE PATERNITY TESTING IS NOT A STANDARD HOSPITAL SERVICE ACROSS ALL MEDICAL FACILITIES.

HOSPITALS TYPICALLY FOCUS ON THE HEALTH AND WELL-BEING OF THE MOTHER AND CHILD, AND PATERNITY TESTING MAY ONLY BE CONDUCTED WHEN REQUESTED BY LEGAL AUTHORITIES OR AS PART OF MEDICAL PROCEDURES LIKE MATERNITY WARD ADMISSIONS. SOME HOSPITALS COLLABORATE WITH CERTIFIED LABORATORIES TO FACILITATE DNA TESTING, BUT THE ACTUAL ANALYSIS IS USUALLY DONE OFFSITE. UNDERSTANDING THESE PROTOCOLS IS CRUCIAL TO MANAGING EXPECTATIONS WHEN SEEKING A PATERNITY TEST IN A HOSPITAL SETTING.

WHEN DO HOSPITALS CONDUCT PATERNITY TESTS?

HOSPITALS MAY CONDUCT OR FACILITATE PATERNITY TESTING IN THE FOLLOWING SCENARIOS:

- AT THE REQUEST OF THE PARENTS OR LEGAL GUARDIANS SHORTLY AFTER BIRTH

OUTSIDE OF THESE SITUATIONS, HOSPITALS GENERALLY DO NOT PROVIDE PATERNITY TESTS AS A ROUTINE SERVICE.

TYPES OF PATERNITY TESTS OFFERED IN MEDICAL SETTINGS

THERE ARE SEVERAL FORMS OF PATERNITY TESTING, BUT HOSPITALS PRIMARILY DEAL WITH DNA TESTING, WHICH IS THE MOST ACCURATE AND WIDELY ACCEPTED METHOD. HOSPITALS MAY OFFER NON-INVASIVE PRENATAL PATERNITY TESTS OR POSTNATAL DNA TESTS DEPENDING ON THE STAGE OF PREGNANCY OR BIRTH.

Non-Invasive Prenatal Paternity Testing (NIPP)

THIS TEST CAN BE PERFORMED DURING PREGNANCY, TYPICALLY AFTER THE EIGHTH WEEK OF GESTATION. IT INVOLVES ANALYZING FETAL DNA CIRCULATING IN THE MOTHER'S BLOOD TO DETERMINE PATERNITY WITHOUT THE RISKS ASSOCIATED WITH INVASIVE PROCEDURES. SOME HOSPITALS MAY OFFER OR FACILITATE THIS TEST THROUGH SPECIALIZED LABS, MAKING IT A SAFER OPTION FOR EXPECTANT MOTHERS.

Postnatal DNA Paternity Testing

AFTER THE BABY IS BORN, HOSPITALS CAN COLLECT DNA SAMPLES FROM THE CHILD AND THE ALLEGED FATHER USING BUCCAL SWABS OR BLOOD SAMPLES. THIS TYPE OF TESTING IS STRAIGHTFORWARD AND HIGHLY ACCURATE. SINCE NOT ALL HOSPITALS PROVIDE PATERNITY TESTING, MANY INDIVIDUALS TURN TO EXTERNAL LABORATORIES AND HOME TESTING KITS FOR THIS SERVICE. THESE ALTERNATIVES OFFER FLEXIBILITY AND CONVENIENCE BUT VARY IN TERMS OF LEGAL ACCEPTABILITY AND ACCURACY.

CERTIFIED PATERNITY TESTING LABORATORIES

HOME PATERNITY TEST KITS

COSTS AND ACCURACY OF HOSPITAL PATERNITY TESTS
